- 3. <u>Termination.</u> Merchant acknowledges and agrees that the Collateral Assignment of Trademarks has been terminated.
- 4. <u>Authorization</u>. Merchant hereby authorizes the Company or the Company's agent to record this Notice of Release Security Interest in Trademarks with the United States Patent and Trademark Office and any foreign trademark office as required.
