# TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "<u>Termination and Release</u>") dated as of July 20, 2020 from WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, in its capacity as administrative agent (in such capacity, the "<u>Administrative Agent</u>") for the Lenders (as defined below), to THE KRYSTAL COMPANY, a Tennessee corporation ("<u>Krystal</u>") and KRYSTAL TRADEMARK COMPANY, a Nevada corporation ("<u>Krystal Trademark</u>" and together with Krystal, collectively, the "<u>Grantors</u>" and each individually, a "<u>Grantor</u>").

### WITNESSETH:

WHEREAS, the Administrative Agent and certain of the Grantors were party to (i) that certain Credit Agreement, dated as of March 21, 2012 (as amended, amended and restated, restated, supplemented, modified or otherwise in effect from time to time, the "Credit Agreement"), by and among the Administrative Agent, certain of the Grantors and each of the financial institutions from time to time party thereto (collectively, the "Lenders" and individually, a "Lender"); (ii) that certain Security Agreement, dated as of March 21, 2012 (as amended, supplemented or restated from time to time, the "2012 Security Agreement"); and (iii) that certain Security and Pledge Agreement, dated as of August 4, 2015 (as amended, modified, extended, restated, renewed, replaced, or supplemented from time to time, the "2015 Security Agreement" and, together with the Credit Agreement and 2012 Security Agreement, the "Transaction Agreements");

WHEREAS, in connection with the transactions contemplated by the Transaction Agreements, the Administrative Agent and the Grantors entered into (i) that certain Trademark Security Agreement, dated as of March 21, 2012, in favor of the Administrative Agent for the benefit of the Lenders (as amended, amended and restated, restated, supplemented, modified or otherwise in effect immediately prior to the date hereof, the "2012 Trademark Agreement"); (ii) that certain Amended and Restated Trademark Security Agreement, dated as of June 28, 2013, in favor of the Administrative Agent for the benefit of the Lenders (as amended, amended and restated, restated, supplemented, modified or otherwise in effect from time to time, the "2013 Trademark Agreement"); (iii) that certain Notice of Grant of Security Interest in Trademarks, dated as of August 4, 2015, in favor of the Administrative Agent for the benefit of the Lenders (the "2015 Trademark Notice"); (iv) that certain Notice of Grant of Security Interest in Trademarks, dated as of April 26, 2018, in favor of the Administrative Agent for the benefit of the Lenders (the "2018 Trademark Notice"); and (v) that certain Notice of Grant of Security Interest in Trademarks, dated as of July 25, 2019, in favor of the Administrative Agent for the benefit of the Lenders (the "2019 Trademark Notice"); pursuant to which a security interest was granted by the Grantors to the Administrative Agent in all right, title and interest in or to any and all of the trademark collateral of such Grantors (collectively, the "Trademark Collateral") including Trademarks identified on Exhibit A attached hereto (and more fully described in the 2012 Trademark Agreement, the 2013 Trademark Agreement, the 2015 Trademark Notice, the 2018 Trademark Notice and the 2019 Trademark Notice);

WHEREAS, as of June 19, 2019, Krystal Trademark voluntarily dissolved and such dissolution was accepted by the Nevada Secretary of State (the "<u>Dissolution</u>"). All assets owned by Krystal Trademark were automatically distributed to Krystal (the "<u>Distribution</u>") in connection with the Dissolution. As of the Dissolution, Krystal Trademark owned the trademarks and trademark applications set forth on <u>Exhibit A</u> attached hereto. The undersigned parties acknowledge the Dissolution and Distribution, and further acknowledge the Administrative Agent's continuing security interest in and continuing lien upon, the trademarks and trademark applications previously owned by Krystal Trademark and now owned by Krystal, as set forth on <u>Exhibit A</u> attached hereto.

WHEREAS, the 2012 Trademark Agreement was recorded in the Trademark Division of the USPTO on March 21, 2012 at Reel 4740, Frame 0781;

WHEREAS, the 2013 Trademark Agreement was recorded in the Trademark Division of the USPTO on June 28, 2013 at Reel 005060, Frame 0460;

WHEREAS, the 2015 Trademark Notice was recorded in the Trademark Division of the USPTO on August 4, 2015 at Reel 005592, Frame 0746;

WHEREAS, the 2018 Trademark Notice was recorded in the Trademark Division of the USPTO on April 27, 2018 at Reel 6321, Frame 0420;

WHEREAS, the 2019 Trademark Notice was recorded in the Trademark Division of the USPTO on July 25, 2019 at Reel 6703, Frame 0798;

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby agrees and acknowledges as follows:

- 1. <u>Definitions</u>. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Transaction Agreements, as applicable.
- 2. <u>Release of Security Interest</u>. The Administrative Agent hereby terminates, releases and discharges its security interest in the Trademark Collateral, including the Trademarks identified on <u>Exhibit A</u> attached hereto and made a part hereof, and assigns to the Grantors, without recourse, all of the Administrative Agent's right, title and interest in the Trademarks, and any right, title or interest of the Administrative Agent in such Trademark shall hereby cease and be void. The Administrative Agent understands and agrees that this Termination and Release may be recorded by or for the Grantors with the USPTO or any similar office or agency.
- 3. <u>Further Assurances</u>. Upon request by the Grantors, the Administrative Agent hereby agrees to duly execute, acknowledge and deliver any further documents and to do such other acts as may be reasonably necessary to effect the termination and release of the security interest contemplated hereby.
