ASSIGNMENT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS

This ASSIGNMENT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS, dated as of July 31, 2020 (this "Assignment"), by and among JEFFERIES FINANCE LLC as successor Administrative Agent and Collateral Agent (each as defined in the Credit Agreement described below) (in such capacity, the "Successor Agent"), CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as Administrative Agent and Collateral Agent (in such capacity, the "Existing Agent"), TRICO GROUP, LLC, a Delaware limited liability company (the "Borrower"), TRICO GROUP HOLDINGS, LLC, a Delaware limited liability company ("Parent") and the other Loan Parties hereto. Capitalized terms used herein without definition shall have the meanings attributed to such terms in the Credit Agreement and First Lien Successor Agent Agreement (each as defined below), as applicable.

WHEREAS, the Borrower, Parent, the banks, financial institutions and other Persons from time to time parties thereto and Goldman Sachs Bank USA, as administrative agent and collateral agent, entered into that certain First Lien Term Loan Agreement, dated as of February 2, 2018 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"). On February 26, 2019, the administrative agent and collateral agent roles were assigned to Credit Suisse pursuant to that certain Successor Agent Agreement, dated as of February 26, 2019, by and among Goldman Sachs Bank USA, Credit Suisse, Parent, Borrower, and the other Loan Parties party thereto.

WHEREAS, the parties are entering into that certain First Lien Successor Agent Agreement, dated as of the date hereof (as amended, amended and restated, supplemented or otherwise modified from time to time, the "First Lien Successor Agent Agreement"), pursuant to which the Existing Agent is resigning as the Administrative Agent and Collateral Agent and the Successor Agent is being appointed to act as the successor Administrative Agent and successor Collateral Agent under the Loan Documents;

WHEREAS, in connection with the First Lien Successor Agent Agreement, Existing Agent is assigning to Successor Agent each of the Liens and security interests granted to the Existing Agent in its capacity as the Collateral Agent under the Collateral Documents, including that certain (i) First Lien Intellectual Property Security Agreement, dated as of February 2, 2018, made by Trico Products Corporation, Strongarm, LLC, and Carter Fuel Systems, LLC (recorded with the United States Patent and Trademark Office at Reel/Frame 045252/0800 in respect of patents, and Reel/Frame 6266/0235 in respect of trademarks, and Volume/Document V9955D302 in respect of copyrights), (ii) First Lien Intellectual Property Security Agreement Supplement, dated as of February 26, 2019, made by Trico Products Corporation, Carter Fuel Systems, LLC, and Heatherton Holdings, LLC (recorded with the United States Patent and Trademark Office at Reel/Frame 048455/0980 in respect of patents, and Reel/Frame 6583/0846 in respect of trademarks), (iii) First Lien Intellectual Property Security Agreement Supplement, dated as of April 20, 2020, made by Trico Products Corporation, Fram Group IP LLC, Strongarm, LLC, Carter Fuel Systems, LLC, and Heatherton Holdings, LLC (recorded with the United States Patent and Trademark Office at Reel/Frame 052472/0057 in respect of patents, and Reel/Frame 6921/0109 in respect of trademarks), and (iv) First Lien Intellectual Property Security Agreement, dated as of January 14, 2019, made by ASC Industries, Inc. (recorded with the United States Patent and Trademark Office at Reel/Frame 048469/0451 in respect of patents, and 6577/0445 in respect of trademarks) (each such agreement, as amended, restated, amended and restated, supplemented or otherwise modified from time to time, and each such grantor thereunder, a "Grantor" and, collectively, the "Grantors") (the foregoing, collectively, the "First Lien IP Security Agreements");

WHEREAS, pursuant to the Collateral Documents, including the First Lien IP Security Agreements, as security for the payment or performance, as the case may be, in full of the Secured Obligations, each Grantor granted to the Existing Agent and its successors and assigns, for the ratable benefit of the Secured Parties, a security interest in all of such Grantor's right, title and interest in and to

certain Collateral, including, without limitation, the Patents set forth in Schedule A hereto, the Trademarks set forth in Schedule B hereto, and the Copyrights set forth in Schedule C hereto (collectively, the “Intellectual Property Collateral”);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by each of the parties hereto, the parties hereto, intending to be legally bound, hereby agree as follows:

1. The Existing Agent hereby assigns to the Successor Agent each of the Liens and security interests granted to the Existing Agent in its capacity as the Collateral Agent under the Collateral Documents (including the IP Security Agreements) for its benefit and the benefit of the Secured Parties, together with any claims, awards, and judgments, if any, in favor of the Existing Agent in its capacity as the Collateral Agent under the Collateral Documents (including the IP Security Agreements), and the Successor Agent in its capacity as the successor Collateral Agent hereby assumes all such Liens and security interests, for its benefit and for the benefit of the Secured Parties. Notwithstanding anything herein to the contrary or the effectiveness of the terms hereof, the Loan Parties agree that all such Liens and all guarantees by each Loan Party of the Obligations pursuant to the Guaranty shall in all respects be continuing and in effect and are hereby ratified and reaffirmed by the Loan Parties.

2. The parties hereby authorize and request (i) the Commissioner of Patents to record this Assignment in the United States Patent and Trademark Office, (ii) the Commissioner of Trademarks to record this Assignment in the United States Patent and Trademark Office, and (iii) the Register of Copyrights of the United States Copyright Office to record this Assignment in the United States Copyright Office.

3. This Assignment has been entered into pursuant to and in conjunction with the First Lien Successor Agent Agreement, which is hereby incorporated by reference herein. The provisions of the First Lien Successor Agent Agreement shall supersede and control over any conflicting or inconsistent provision herein. The rights and remedies of the Successor Agent with respect to the Intellectual Property Collateral are as provided by the Loan Documents (including the IP Security Agreements), and nothing in this Assignment shall be deemed to limit such rights and remedies.

4. THIS ASSIGNMENT SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK (INCLUDING NEW YORK GENERAL OBLIGATIONS LAW SECTION 5-1401).

5. The parties hereby agree and acknowledge that, from and after the Effective Time, Successor Agent shall be, and shall be deemed to be, the Administrative Agent and the Collateral Agent under the Credit Agreement and the other Loan Documents (including the IP Security Agreements). In furtherance of the foregoing, as of the Effective Time, unless the context otherwise requires, all recitals, introductory paragraphs, defined terms and other references to “Credit Suisse AG, Cayman Islands Branch” as the Administrative Agent and/or the Collateral Agent in the Credit Agreement and the other Loan Documents (including the IP Security Agreements) are hereby deemed amended to reference “Jefferies Finance LLC” as the Administrative Agent and/or Collateral Agent, as applicable, thereunder.



Upon the execution and delivery of this Assignment by the Existing Agent, the Successor Agent, and the Loan Parties, this Assignment shall be deemed to be a Loan Document, and the Credit Agreement and the other Loan Documents shall, where the context requires, be read and construed throughout so as to incorporate this Assignment.



Each of the parties hereto represents and warrants to the other parties hereto that it has the corporate capacity and authority to execute this Assignment through electronic means and there are no restrictions for doing so in that party’s constitutive documents. For the avoidance of doubt, the foregoing also applies to any amendment, extension or renewal of this Assignment.
