This TRADEMARK NOTICE OF SUCCESSION OF AGENCY (this “Notice”), dated as of July 31, 2020 (the “Effective Date”), is executed by Jefferies Finance LLC, in its capacity as Administrative Agent under the Original Agreements (as defined below) (the “Prior Agent”), and KKR Loan Administration Services LLC, in its capacity as Administrative Agent under the Current Agreements (as defined below) (the “Successor Agent”).

WHEREAS, pursuant to that certain Credit Agreement, dated as of June 1, 2015, by and among Epicor Software Corporation (the “Borrower”), Prior Agent and certain other parties thereto (as amended by that certain First Incremental Agreement, dated as of August 31, 2016, that certain Second Incremental Agreement dated as of August 16, 2017, that certain Third Amendment, dated as of February 5, 2018, that certain Fourth Amendment, dated as of June 29, 2018 and that certain Fifth Amendment, dated as of May 18, 2020, the “Original Credit Agreement”), the Prior Agent and certain grantor parties identified on the signature page hereto (the “Grantors”) entered into that certain Security Agreement, dated as of June 1, 2015 (the “Original Security Agreement”), and the Intellectual Property Security Agreement, dated as of June 1, 2015 (the “Original Intellectual Property Security Agreement”), as supplemented by that certain Intellectual Property Security Agreement Supplement (Trademarks), dated as of June 9, 2016 (the “Trademarks Supplement No. 1”), as further supplemented by that certain Intellectual Property Security Agreement Supplement (Trademarks), dated as of August 15, 2016 (the “Trademarks Supplement No. 2”), as further supplemented by that certain Intellectual Property Security Agreement Supplement (Trademarks), dated as of August 31, 2016 (the “Trademarks Supplement No. 3”), as further supplemented by that certain Intellectual Property Security Agreement Supplement (Trademarks), dated as of February 17, 2017 (the “Trademarks Supplement No. 4”), as further supplemented by that certain Intellectual Property Security Agreement Supplement (Trademarks), dated as of May 15, 2019 (the “Trademarks Supplement No. 5”), as further supplemented by that certain Intellectual Property Security Agreement Supplement (Trademarks), dated as of October 25, 2019 (the “Trademarks Supplement No. 7”), as further supplemented by that certain Intellectual Property Security Agreement Supplement (Trademarks), dated as of October 25, 2019 (the “Trademarks Supplement No. 8”) and as further amended, supplemented or otherwise modified as of the date hereof, the “Original Trademark Security Agreement”, and together with the Original Credit Agreement and the Original Security Agreement, the “Original Agreements”) pursuant to which the Grantors granted a security interest in and to certain collateral;

WHEREAS, (i) the Original Intellectual Property Security Agreement was recorded with the Trademarks Division of the U.S. Patent & Trademark Office on June 3, 2015 at Reel/Frame 5544/0057, (ii) the Trademarks Supplement No. 1 was recorded with the Trademarks Division of the U.S. Patent & Trademark Office on June 10, 2016 at Reel/Frame 5811/0334, (iii) the Trademarks Supplement No. 2 was recorded with the Trademarks Division of the U.S. Patent & Trademark Office on August 15, 2016 at Reel/Frame 5855/0001, (iv) the Trademarks Supplement No. 3 was recorded with the Trademarks Division of the U.S. Patent & Trademark Office on August 31, 2016 at Reel/Frame 5869/0945, (v) the Trademarks Supplement No. 4 was recorded with the Trademarks Division of the U.S. Patent & Trademark Office on February 17, 2017 at Reel/Frame 5992/0229, (vi) the Trademarks Supplement No. 5 was recorded with the Trademarks Division of the U.S. Patent & Trademark Office on May 24, 2019 at Reel/Frame 6653/0079, (vii) the Trademarks Supplement No. 7 was recorded with the Trademarks Division of the U.S. Patent & Trademark Office on October 25, 2019 at Reel/Frame 6780/0143, (viii) the Trademarks Supplement No. 8 was recorded with the Trademarks Division of the U.S. Patent & Trademark Office on October 25, 2019 at Reel/Frame 6780/0135, with respect to the patents identified on Schedule A attached hereto;

WHEREAS, the Original Credit Agreement was amended and restated, as of July 31, 2020 (as amended and restated, collectively, the “Current Agreements”), and in connection with the transactions under the Current Agreements, the Prior Agent, the Successor Agent, the Borrower and certain other parties have entered into that certain Resignation, Consent and Appointment Agreement, dated as of July 31, 2020 (the “Resignation Agreement”), whereby the Prior Agent resigned as Administrative Agent and is succeeded to and replaced by the Successor Agent as successor Administrative Agent;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Resignation Agreement.


2. Succession and Replacement of Agency. Pursuant to the terms and conditions set forth in the Resignation Agreement, the Prior Agent has ceased to be Administrative Agent under such capacity and is succeeded to and replaced by the Successor Agent as Administrative Agent under such capacity. Nothing herein shall be deemed to terminate, interrupt or impair the continuity of the security interest in the collateral originally granted to the Prior Agent under the Original Trademark Security Agreement, which security interest is now succeeded by and transferred to the Successor Agent.
