**FIRST:** The name and state of incorporation of each of the constituent corporations to the merger are Cardinal Industries, Inc., a New York corporation, Swimways Corp., a Commonwealth of Virginia corporation, and SPIN MASTER, INC., a Delaware corporation.

**FIFTH:** The Agreement and Plan of Merger as executed is on file at the principal place of business of the Surviving Corporation at:


