An assignment of the registration for the mark SCORE (stylized) & Design (U.S. reg no. 4858107) (the "Registration") was recorded in error on July 8, 2020 (at reel: 006690 frame: 0559 – 0561). The rightful owner of the Registration, Mr. Serghei Luchian, and his predecessor-in-interest, BeerStream, LLC ("BeerStream"), respectfully request that the Patent and Trademark Office correct its owner entity records for the Registration by recording the assignment document attached hereto.

On May 29, 2020, an assignment was submitted which assigned all rights in the Registration from BeerStream to Mr. Luchian. This assignment was executed *nunc pro tunc*, with an effective date of May 12, 2020. This assignment was duly recorded on May 29, 2020 (reel: 006948 frame: 0752 - 0754).

On July 8, 2020, an individual named Sergey Novov, acting through counsel, submitted for recordation a document which purported to assign rights in the Registration from BeerStream to Mr. Novov, who executed the supporting assignment on behalf of BeerStream. Mr. Novov possessed no authority to assign the Registration from Beerstream to himself; moreover, the effective date of the purported assignment, June 3<sup>rd</sup>, 2020, is well after the properly-recorded assignment from Beerstream to Mr. Luchian took place on May 12, 2020.

I have attempted to contact the attorney who filed the wrongful assignment, but he has not responded.

We thus request that the Office's ownership records for the Registration be corrected and that the attached assignment be re-recorded.


**Declaration of Serghei Luchian regarding U.S. Trademark Registration  
No. 4858107 for SCORE (stylized characters) & Design**

I, Serghei Luchian, hereby declare as follows:

1. I am the correct, current owner of the trademark SCORE (stylized characters) & Design (the "SCORE Mark"), shown in U.S. trademark registration no. 4858107 (the "Registration"). I have personal knowledge of the facts stated below.
2. On May 28, 2020, in my capacity as a principal of Florida limited liability company BeerStream LLC ("BeerStream"), I executed a written assignment of the SCORE Mark, including the corresponding Registration, from BeerStream to myself in my individual capacity. The assignment was executed *nunc pro tunc*, reflecting the effective date for the assignment of May 12, 2020.
3. At my direction, on May 29, 2020, my attorney submitted the executed assignment document to the U.S. Patent and Trademark Office for recordation; we subsequently received a Notice of Recordation of Assignment stating that the assignment had been duly recorded (Reel: 006948 Frame: 0752 - 0754).
4. My attorney subsequently notified me that on July 8, 2020, an attorney acting on behalf of an individual named Sergey Novov had submitted for recordation an assignment document that purported to assign the SCORE Mark and corresponding Registration from BeerStream to Mr. Novov (Reel: 006690 Frame: 0559 - 0561).
5. At no time did Mr. Novov possess any authority or standing to assign the SCORE Mark or the Registration from BeerStream to himself.
6. The purported assignment of the SCORE Mark and Registration appears to have been executed on June 3, 2020, after the SCORE Mark Registration already had been properly assigned to me.
7. I am requesting that the U.S. Patent and Trademark Office update and correct its records for the Registration to reflect the fact that I am the owner of the SCORE Mark and the Registration.
