**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This Release of Security Interest in Intellectual Property (this “**Release**”) is effective as of August 28, 2020 by Cerberus Business Finance, LLC, a Delaware limited liability company, as assignee of Credit Suisse AG, Cayman Islands Branch (the “**Agent**”), for the benefit of the parties listed on Schedule I attached hereto (each a “**Grantor**” and collectively the “**Grantors**”). All capitalized terms used but not otherwise defined herein shall have the respective meanings assigned thereto in the Security Agreement.

WITNESSETH:

**WHEREAS**, the Grantors entered into that certain Pledge and Security Agreement, dated November 7, 2014, as amended by that certain Supplement No. 1, dated July 10, 2015 (as amended, restated, amended and restated, supplemented, modified or otherwise changed from time to time, the “**Security Agreement**”), in favor of the Agent;

**WHEREAS**, pursuant to the Security Agreement, the Grantors entered into certain Intellectual Property Security Agreements and Intellectual Property Security Agreement Supplements listed on Schedule I hereto (each an “**IP Security Agreement**” and collectively, the “**IP Security Agreements**”), pursuant to which such Grantor pledged, collaterally assigned, mortgaged, transferred and granted to the Agent, its successors and permitted assigns, on behalf of and for the ratable benefit of the Secured Parties, a continuing security interest in all of its right, title and interest in, to or under all of the following assets, whether then owned or at any time thereafter acquired by or arising in favor of such Grantor and regardless of where located (collectively, the “**IP Collateral**”):

- i) (a) all trademarks (including service marks), common law marks, trade names, trade dress, and logos, slogans and other indicia of origin under the Requirements of Laws of any jurisdiction in the world, and the registrations and applications for registration thereof and the goodwill of the business symbolized by the foregoing, (b) all renewals of the foregoing, (c) all income, royalties, damages, and payments now or hereafter due or payable with respect thereto, including, without limitation, damages, claims, and payments for past and future infringements thereof, (d) all rights to sue for past, present and future infringements of the foregoing, including the right to settle suits involving claims and demands for royalties owing, and (e) all domestic rights corresponding to any of the foregoing (“**Trademarks**”), including the Trademark registrations and registration applications in the United States Patent and Trademark Office listed on Schedule II hereto;
- ii) (a) all copyrights, rights and interests in copyrights, works protectable by copyright whether published or unpublished, copyright registrations and copyright applications, (b) all renewals of any of the foregoing, (c) all income, royalties, damages, and payments now or hereafter due and/or payable under any of the foregoing, including, without limitation, damages or payments for past or future infringements for any of the foregoing, (d) the right to sue for past present and future infringement of any of the foregoing, and (e) all rights corresponding to any of the foregoing (“**Copyrights**”),

including the Copyright registrations and registration applications in the United States Copyright Office listed on Schedule III hereto;

- iv) all proceeds of the foregoing; in each case to the extent the foregoing items constitute Collateral.

**WHEREAS**, the Grantors have requested that the Agent release, and the Agent is willing to release its lien on and security interest in, and any other right, title, and interest it may have in, to and under the IP Collateral; and

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent does hereby terminate the IP Security Agreements and terminate, release, discharge and reassigns to the Grantors the entirety of any and all security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the IP Security Agreements to the IP Collateral and any right, title or interest of the Agent in such IP Collateral, if any, shall hereby terminate, cease and become void.
