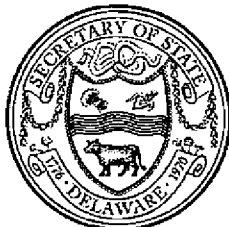



Under Section 242 of the Delaware General Business Law

Pursuant to the provisions of Section 242 of the Delaware General Corporation Law, the undersigned, being an authorized person of the Corporation, hereby certifies and sets forth as follows:

**FIRST:** The name of the corporation is techCare, Inc. (the "Corporation").

**SECOND:** The original Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on April 18, 2013.

**THIRD:** The Amended and Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on the 9<sup>th</sup> day of July, 2014.

**FOURTH:** The Amended and Restated Certificate of Incorporation is hereby amended to change the name of the Corporation pursuant to Section 242 of the General Corporation Law. Section "FIRST" is hereby amended as follows:

**FIRST:** The name of the Corporation is Pager, Inc., and the original Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on April 18, 2013.

**FIFTH:** By written consent of the stockholders of the Corporation, agreed to the amendment above in accordance with the provisions of Section 228 of the General Corporation Law of the State of Delaware.

**SIXTH:** The aforesaid amendment was duly adopted in accordance with the applicable provisions of Section 242 of the General Corporation Law of the State of Delaware.
