TRADEMARK ASSIGNMENT

This Trademark Assignment, effective as of October 6, 2020 (hereinafter, "**Effective Date**") is between Ideavillage Products Corp., a corporation organized and existing under the laws of the State of New Jersey with an address of 155 Route 46 West, Wayne, NJ 07470 (hereinafter, the "**Assignor**") and IDVC, LLC, a limited liability company organized and existing under the laws of the State of Delaware with an address of 155 Route 46 West, Wayne, NJ 07470 (hereinafter, the "**Assignee**"). Assignor and Assignee are sometimes referred to herein individually as a "**Party**" and collectively as the "**Parties**".

WHEREAS, Assignor is the sole and exclusive legal and record owner of all rights, title, and interest in and to the trademarks listed in **Schedule A** attached hereto (hereinafter, the "**Assigned Trademarks**"), the applications and registrations thereof, and the goodwill of the business connected with the use of, and symbolized by, the Assigned Trademarks;

WHEREAS, Assignee desires to acquire all rights, title, and interest in and to the Assigned Trademarks, the applications and registrations thereof, and the goodwill of the business connected with the use of, and symbolized by, the Assigned Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Conveyance, Assignment, and Transfer. Assignor hereby irrevocably conveys, transfers, grants, and assigns to Assignee, and Assignee hereby accepts, all of Assignor's rights, title, and interest, whether statutory or at common law, in, to, and under the following:
 - a. The Assigned Trademarks and all applications, registrations, issuances, extensions, and renewals thereof;
 - b. The goodwill of the business connected with the use of, and symbolized by, the Assigned Trademarks;
 - c. The right to all claims against third parties for damage and compensation relating to or arising from the use and registration of the Assigned Trademarks, and/or the applications and registrations thereof, with the right to sue for and collect the same;
 - d. Any and all royalties, fees, income, payments, and other proceeds, now or hereafter due or payable, with respect to any and all of the foregoing; and
 - e. All of Assignor's rights, of any kind whatsoever, accruing under any of the foregoing, provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world.
2. Recordation. Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of governmental entities or agencies in any other applicable jurisdiction to record and register this Trademark Assignment upon request by Assignee.
3. Amendments. This Trademark Assignment can be modified only by a written instrument signed by authorized representatives of both Parties.

4. Binding Effect. This Trademark Assignment shall be binding upon and inure to the benefit of the Parties, their respective licensees, assignees, and successors.
5. Severability. Should any provision of this Trademark Assignment be invalid or unenforceable, the remaining provisions of this Trademark Assignment shall be valid. In the place of an invalid provision, a valid provision, which comes economically closest to the one actually agreed upon, is presumed to be agreed upon by the Parties.
6. Counterparts. This Trademark Assignment may be executed by the Parties in counterparts, each of which, when executed, shall be deemed an original and shall together constitute a single document. Faxed or scanned copies shall be deemed as originals.
7. Headings. The headings referenced herein are for convenience purposes only, do not constitute a part of this Trademark Assignment, and shall not be deemed to limit or affect any of the provisions hereof.


