TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT (this "<u>Agreement</u>") is made this 6th day of October, 2020, by and among the Grantor listed on the signature pages hereof (the "<u>Grantor</u>"), and Ally Bank, in its capacity as agent for the Secured Parties (in such capacity, the "<u>Administrative Agent</u>").

WITNESSETH:

- A. WHEREAS, reference is made to that certain Revolving Credit and Term Loan Agreement, dated as of October 6, 2020 (as amended, restated, extended, supplemented or otherwise modified in writing from time to time, the "Credit Agreement"), by and among Production Resource Group Inc., a Delaware corporation ("Initial Holdings" and, until the occurrence of the Restructuring Purchase Agreement Closing (as defined in the Credit Agreement), "Holdings"), Magic To Do 2020 Inc., a Delaware corporation ("Ultimate Holdings", and, effective as of, and from and after, the Restructuring Purchase Agreement Closing, "Holdings"), Production Resource Group, L.L.C., a Delaware limited liability company and wholly-owned subsidiary of Holdings ("PRG" or, the "Borrower"), the Subsidiary Parties (as defined below) from time to time party hereto and Ally Bank, in its capacity as agent for the Secured Parties (as defined in the Credit Agreement referred to below) (in such capacity, the "Administrative Agent" or "Agent");
- B. **WHEREAS**, reference is also made to that certain Pledge and Security Agreement, dated as of October 6, 2020 (as it may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), by and among the Grantor, the other grantors party thereto and the Administrative Agent; and
- C. WHEREAS, under the terms of the Security Agreement, the Grantor has (i) as collateral security for the Secured Obligations, granted to the Administrative Agent a first priority security interest in and continuing lien on all of the Grantor's right, title and interest in, to and under the Collateral (as defined in the Security Agreement), including, without limitation, certain Trademarks (as defined below) of the Grantor and (ii) agreed to execute this Agreement for recording with the United States Patent and Trademark Office and other applicable Governmental Authorities.
- **NOW, THEREFORE**, in consideration of the premises and the agreements, provisions and covenants herein contained, the Grantor and the Administrative Agent agree as follows:
- Section 1. <u>DEFINED TERMS</u>. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement or, if not defined therein, in the Credit Agreement.
- Section 2. <u>GRANT OF SECURITY</u>. The Grantor hereby unconditionally grants, assigns, and pledges to Administrative Agent, for the benefit of the Secured Parties, to secure the Secured Obligations, a continuing security interest in all of the Grantor's right, title and interest in and to the following, whether now owned or hereafter acquired or arising, in, to and under the following (collectively, the "<u>Trademarks</u>"):

- (i) all trademarks (including service marks), trade names, trade dress, and trade styles and the registrations and applications for registration thereof including, without limitation, the registrations and applications referred to in <u>Schedule I</u> hereto, and the goodwill of the business symbolized by the foregoing; (ii) all licenses of the foregoing, whether as licensee or licensor; (iii) all renewals of the foregoing; (iv) all income, royalties, damages, and payments now or hereafter due or payable with respect thereto, including, without limitation, damages, claims, and payments for past and future infringements thereof; (v) all rights to sue for past, present, and future infringements of the foregoing, including the right to settle suits involving claims and demands for royalties owing; and (vi) all rights corresponding to any of the foregoing throughout the world.
- Section 3. <u>SECURITY AGREEMENT</u>. The security interest granted pursuant to this Agreement is granted in conjunction with the security interests granted to Administrative Agent, for the benefit of the Secured Parties, pursuant to the Security Agreement. Grantor hereby acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the security interest in the Trademarks made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. To the extent there is any inconsistency between this Agreement and the Security Agreement, the Security Agreement shall control.
- Section 4. <u>AUTHORIZATION TO SUPPLEMENT</u>. If the Grantor shall obtain rights to any new Trademarks, the provisions of this Agreement shall automatically apply thereto. Grantor shall give prompt notice in writing to the Administrative Agent with respect to any such new Trademark or renewal or extension of any Trademark registration. Without limiting Grantor's obligations under this Section, Grantor hereby authorizes the Administrative Agent to unilaterally modify this Agreement by amending <u>Schedule I</u> to include any such new Trademark rights of Grantor. Notwithstanding the foregoing, no failure to so modify this Agreement or amend <u>Schedule I</u> shall in any way affect, invalidate or detract from the Administrative Agent's continuing Security Interest in all Trademarks, whether or not listed on <u>Schedule I</u>.
- Section 5. <u>RECORDATION</u>. Grantor authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Agreement.
- Section 6. <u>COUNTERPARTS</u>. This Agreement is a Loan Document. This Agreement may be executed in any number of counterparts (including by ".pdf" or other electronic transmission, which shall have the same force and effect as manually signed originals and shall be binding on all of the parties hereto), all of which taken together shall constitute one agreement, and any of the parties hereto may execute this Agreement by signing any such counterpart.
- Section 7. CHOICE OF LAW, CONSENT TO JURISDICTION AND WAIVER OF JURY TRIAL. THIS AGREEMENT SHALL BE SUBJECT TO THE PROVISIONS REGARDING CHOICE OF LAW, CONSENT TO JURISDICTION AND WAIVER OF JURY TRIAL SET FORTH IN SECTIONS 7.17, 7.18 AND 7.19 OF THE SECURITY AGREEMENT, AND SUCH PROVISIONS ARE INCORPORATED HEREIN BY THIS REFERENCE, MUTATIS MUTANDIS.
