**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY**

September 30, 2020

WHEREAS, SpeedCast International Limited, an Australian company with Australian Company Number 600 699 241 (“SpeedCast”) entered into the U.S. Intellectual Property Security Agreement, dated as of April 24, 2020 (the “First IP Security Agreement”), made by SpeedCast in favor of Black Diamond Commercial Finance, L.L.C. (as successor by assignment from Credit Suisse AG, Cayman Islands Branch) (the “Security Trustee”);

WHEREAS, SpeedCast Limited, a company incorporated under the laws of Hong Kong with its registered office at 2405-08 Everbright Centre, 108 Gloucester Road, Wan Chai, Hong Kong and company registration number 0687568 (“SpeedCast Limited”) entered into the U.S. Intellectual Property Security Agreement, dated as of April 24, 2020 (the “Second IP Security Agreement”), made by SpeedCast Limited in favor of the Security Trustee;

WHEREAS, Globecomm Systems Inc. (“Globecomm Inc.”), Globecomm Services Maryland LLC (“Globecomm LLC”) and Telaurus Communications LLC (“Telarus”, and, together with Globecomm Inc. and Globecomm LLC, the “SpeedCast Subsidiaries”, and the SpeedCast Subsidiaries together with SpeedCast and SpeedCast Limited, each an “IP Grantor” and collectively, the “IP Grantors”) entered into the Intellectual Property Security Agreement, dated as of April 24, 2020 (the “Third IP Security Agreement” and together with the First IP Security Agreement and the Second IP Security Agreement, the “IP Security Agreements”), made by the SpeedCast Subsidiaries in favor of the Security Trustee, as collateral agent (in such role, the “Collateral Agent”);

WHEREAS, pursuant to the IP Security Agreements, each IP Grantor granted a security interest (the “Security Interest”) in all of such IP Grantor’s right, title and interest in and to the Intellectual Property Collateral (as such term is defined in the IP Security Agreement), including (i) the trademarks and the trademark registrations and applications for trademark registration set forth on the attached Schedule 1, and all goodwill of the business connected with the use of, and symbolized by, the foregoing (the “Released Trademarks”), (ii) the patents and patent applications set forth on the attached Schedule 2 (the “Released Patents”) and (iii) the copyright registrations and applications for copyright registration set forth on the attached Schedule 3 (the “Released Copyrights” and, together with the Released Trademarks, Released Patents and Intellectual Property Collateral, the “Released IP”); and

WHEREAS, the Security Trustee has agreed to release its Security Interest in the Released IP, as herein provided.

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, the Security Trustee, on behalf of itself and each of the Secured Parties (as such term is defined in the applicable IP Security Agreement), without warranty or recourse of any kind, hereby: (i) releases and discharges its security interest held in the Released IP; (ii) terminates all its rights, powers, privileges and remedies under the IP Security Agreements with respect to the Released IP; (iii) assigns, re-conveys, re-transfers and sets

over to the IP Grantors any and all right, title or interest that the Security Trustee and any of the Secured Parties may have acquired in any of the Released IP, together with all the goodwill associated therewith or symbolized thereby, and (iii) releases each of the IP Grantors from all covenants, obligations, liabilities and warranties under the IP Security Agreements related to the Released IP.
