TRADEMARK ASSIGNMENT

WHEREAS, Cuisine en Locale, Inc., a company organized under the laws of Massachusetts, located at 156 Highland Avenue, Somerville, Massachusetts 02143 (“Assignor”), is the sole owner of the entire right, title and interest in and to the trademark ONCE that is the subject of U.S. Trademark App. Ser. No. 88938153 for use in Class 41 with “Providing, operating and rental of facilities, premises, venues, ballrooms, lounges, online channels and online mediums for events and programs, namely, creative performance, performing art, music, concert, fitness, game, recreational, civic, cultural, festive, educational and entertainment events and programs; Co-production and distribution of online events and programs, namely, creative performance, performing art, music, concert, fitness, game, recreational, civic, cultural, festive, educational and entertainment events and programs for broadcast, telecast, display or distribution via the Internet and online; Entertainment and event ticketing services; Bar and cocktail lounge services; catering services” (the trademark and the U.S. application collectively the “Mark”), that was first used with such services anywhere at least as early as July 31, 2008, and first used in interstate commerce at least as early as July 31, 2008, and is now is such use in interstate commerce with such services;

WHEREAS, Julia Gonson, an individual and a citizen of the United States of America, located at 67 Pleasant Street, #1, Cambridge, Massachusetts 02139 (“Assignee”), is desirous of acquiring the entire right, title and interest in and to the said Mark, including the goodwill represented by the Mark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby *nunc pro tunc* (now as if before) effective retroactively as of July 31, 2008, sell, assign, transfer, convey and set over unto the Assignee, its successors, and assigns, the entire U.S. and worldwide rights, title and interests in and to said Mark and any applications/registrations therefor, together with the entire goodwill and business associated with and symbolized by the Mark, together with all common law rights, together with all rights and privileges granted and secured thereby, including the right to sue for all causes of action related to the Mark whenever they arose, and the right to sue in Assignee's own name and to recover for any damages and profits for past infringement, unfair competition or passing off, said assignment and conveyance hereby represented and warranted by Assignor to be free and clear of any encumbrances, security interests, liens or hypothecations, and said rights to be held and enjoyed by said Assignee, for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by said Assignor if this Assignment and sale had not been made. Assignor represents and warrants it will not execute any writing or do any act whatsoever conflicting with these covenants and agreements, and that it will, at any time upon request without further or additional consideration or recoupment of expenses or costs, execute such additional assignments and other writing and do such additional acts as said Assignee may deem necessary or desirable to perfect, secure, record, and register said Assignee's enjoyment of this grant, it being understood that the covenants, assignments and agreements herein shall bind assigns and legal representatives of Assignor and inure to the benefit of the successors, assigns and legal representatives of Assignee.
