Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or Security Agreement, as applicable, referred to below.

- A. Reference is made to (i) the Second Lien Credit Agreement, dated as of May 30, 2019, as amended by First Amendment to Second Lien Credit Agreement, dated as of September 25, 2020 (as further amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Toro Private Holdings II, Ltd., Toro Private Holdings III, Ltd., Travelport Finance (Luxembourg) S.à r.l. (the "Borrower"), the lenders from time to time party thereto, Wilmington Savings Fund Society, FSB, as administrative agent (the "Administrative Agent") and the Collateral Agent, (ii) the Second Lien Security Agreement, dated as of May 30, 2019, as supplemented by Supplement No. 1 to Second Lien Security Agreement, dated as of July 15, 2019 (as further amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among the subsidiaries listed therein and the Prior Agent, (iii) the Notice of Succession of Agency, dated as of June 22, 2020, between the Prior Agent and the Collateral Agent (such documents set forth in clauses (i) through (iii), the "Security Documents").
- B.
