## **INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT**

This Intellectual Property Assignment Agreement (the "Agreement") is made this 20th day of May, 2020 (the "Effective Date") by and between HDR Global Trading Limited, a limited company organized under the laws of the Seychelles, with a principal place of business at Suite 202, 2nd Floor, Eden Plaza, Eden Island, Mahé, Seychelles (hereinafter called "ASSIGNOR"), and HDR SG PTE. LTD., a limited company organized under the laws of Singapore, with a principal place of business at 30 Cecil Street, #19-08, Prudential Tower, Singapore 049712 (hereinafter called "ASSIGNEE").

WHEREAS, ASSIGNOR is the owner of certain intellectual property related to operating a website for cryptocurrency platform and trading services, including but not limited to patentable subject matter, trademarks, copyrightable subject matter, and trade secrets associated therewith (hereinafter called the "IP");

WHEREAS, ASSIGNOR agrees to assign all ownership in the IP to ASSIGNEE that ASSIGNOR currently owns or acquires any ownership interest in; and

THEREFORE, ASSIGNOR and ASSIGNEE, for good and valuable consideration, receipt of which is hereby acknowledged, agree as follows:

1. ASSIGNOR does hereby assign unto ASSIGNEE, its successors and assigns, ASSIGNOR's entire right, title and interest in and to the IP that ASSIGNOR presently owns, including all goodwill associated therewith; including IP created prior to the Effective Date of this Agreement and further including, but not limited to any intellectual property, including patentable subject matter, patents, trademarks, service marks, domain names, trade secrets, copyrights, and software embodied therein and renewals and extensions thereof in the IP and all variations or any other derivative works, all object code, source code, and all rights corresponding thereto throughout the world, any license rights pertaining thereto, and any rights to sue and recover for past, present, and future infringement, and including, but not limited to the assets set forth in Schedule 1 and Schedule 2.

2. ASSIGNOR retains no right to use the IP, in whole or in part.

3. Whether rights in certain IP should be formally registered shall be at the sole discretion of ASSIGNEE.

4. ASSIGNOR further agrees to execute any documents that might be necessary to perfect ASSIGNEE's ownership of rights in the IP and to execute any documents and assist ASSIGNEE with registering any copyrights, trademarks or service marks, or applying for any patents in the IP without further remuneration.

5. The parties agree that they have had ample time and opportunity to review this Agreement, had the opportunity to have had counsel of their choosing review this Agreement, and fully understand the terms and conditions contained therein; therefore, this Agreement may not be construed against any one party.

6. The parties agree that, should any provision or section of this Agreement be held to be invalid or unenforceable, that that section or provision shall be stricken from this Agreement and the remainder of the Agreement shall still be considered valid, binding, and in full force.

7. This Agreement constitutes the entire Agreement between the parties hereto for the transfer of rights in and to the IP and supersedes any prior oral or written agreement or understanding between the parties pertaining to the subject matter thereof.

8. The parties agree that this Agreement may be executed in duplicate and that electronic signatures, including DocuSign and .PDF signatures, shall have the same force as original signatures.

9. The parties agree to take further actions and sign additional documents to ensure that the obligations set forth herein are met in accordance with the spirit and terms of this Agreement.


