TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Assignment") is dated and delivered as of October 13, 2020, by and between Campbell Hausfeld, LLC, a Delaware limited liability company (the "Seller") and MAT Industries, LLC, an Illinois limited liability company (the "Buyer"). Seller and Buyer are collectively referred to herein as the "Parties" and each, a "Party."

WHEREAS, Buyer, Seller, and Marmon Holdings, Inc., a Delaware corporation and indirect parent of Seller ("Marmon") have entered into that certain Asset Purchase Agreement, dated as of October 5, 2020 (the "Purchase Agreement"), providing for, among other things, the assignment by the Seller to Buyer of the trademarks identified on Schedule 1 attached hereto, together with the goodwill associated therewith (collectively, the "Trademarks"); and

WHEREAS, Buyer desires to acquire all right, title and interest in and to the Trademarks and the goodwill associated therewith pursuant to the Purchase Agreement.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Seller hereby conveys and assigns to Buyer all of its right, title and interest in and to the Trademarks in the United States and all jurisdictions outside the United States (including all common law rights in and to such Trademarks, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Trademarks, and any priority right that may arise from use of the Trademarks), free and clear of all Liens, and all goodwill represented and symbolized thereby with all rights to sue and recover damages and/or profits for past infringements, the same to be held and enjoyed by Buyer, its successors and assigns as fully and entirely as said interest could have been held and enjoyed by Seller had this conveyance and assignment not been made.

Seller further agrees that, without further consideration, at any time and from time to time upon Buyer's written request, Seller will do, execute, acknowledge, and deliver or cause to be done, executed, acknowledged and delivered, all such further acts, deeds, assignments, transfers, conveyances, instruments, powers of attorney, and assurances as Buyer may reasonably request to effectuate fully this Assignment and to permit Buyer to be duly recorded in all applicable jurisdictions as the registered owner and proprietor of the rights hereby conveyed.

This Assignment is intended to be solely a document to evidence and effectuate assignment and conveyance. In the event of a conflict between the terms and conditions of this Assignment and the terms and conditions of the Purchase Agreement, the terms and conditions of the Purchase Agreement shall govern, supersede and prevail. Nothing contained in this Assignment is intended to, nor shall it, extend, amplify, supersede or otherwise alter the representations, warranties, covenants and obligations of the Parties contained in the Purchase Agreement or the survival thereof.

This Assignment shall inure to the benefit of and be binding upon the Parties and their respective successors and permitted assigns. This Assignment shall be governed by, and construed in accordance with, the Laws of the State of Illinois, without giving effect to any Law or rule that would cause the Laws of any jurisdiction other than the State of Illinois to be applied. A signed copy of this Assignment delivered by facsimile, e-mail, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.
