#### TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment") is made effective as of October 16, 2020 (the "Assignment Date"), by Specialty Retailers, Inc., a Texas corporation ("Assignor") and Bealls, Inc., a Florida corporation ("Assignee"). The parties hereto, along with Burke's DC TX, LLC, a Florida limited liability company ("Purchaser"), and Stage Stores, Inc., a Nevada corporation, have entered into that certain Asset Purchase Agreement dated as of October 4, 2020 (as amended, the "APA"). Pursuant to the APA, Purchaser has designated the Assignee, its Affiliate, to take ownership of the Trademarks (as defined below). Assignor has agreed to transfer and assign to Assignee, and Assignee has agreed to obtain from Assignor, certain of the Acquired Assets (as defined in the APA), including the trademarks listed on Exhibit A hereto (the "Trademarks"). The parties are entering into this Assignment to further evidence the transfer of such Trademarks from Assignor to Assignee. In consideration of the covenants, promises and representations set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

- Section 1. Assignment. Assignor hereby irrevocably transfers, assigns, conveys and delivers to Assignee, its successors, assigns and legal representatives, the entire world-wide right, title and interest in and to the Trademarks, free and clear of all Encumbrances (as defined in the APA), together with all associated goodwill, all applications, renewals, registrations, substitutions, extensions and foreign counterparts thereof, and all other corresponding rights that are or may be secured under the laws of the United States, any foreign country or jurisdiction or any multilateral organization, together with all income, royalties or payments due or payable as of the Assignment Date or thereafter, all claims for damages and the right to sue for, collect, settle or release any past, present or future infringement of any of the Trademarks. Assignor does hereby authorize and request the Commissioner of Patents and Trademarks of the United States of America or equivalent authority elsewhere in the world to record this Assignment. Except as provided in (and subject to the limitations of) the APA, the Trademarks are sold, transferred and conveyed by Assignor to Assignee (i) on an "AS-IS," "WHERE-IS," "WITH ALL FAULTS" basis, and (ii) without any warranties, representations or guaranties, either express or implied, of any kind, nature or type whatsoever.
- Section 2. <u>Assistance</u>. From time to time, as and when reasonably requested by Assignee and at Assignee's expense, Assignor shall execute and deliver, or cause to be executed and delivered, all documents and instruments and shall take all other actions as Assignee may reasonably request to consummate the transactions contemplated by this Assignment. Further, at Assignee's expense, Assignor and its successors and assigns shall testify in any legal proceedings, sign all lawful papers, make all lawful oaths and perform all lawful acts reasonably necessary and proper to vest title to the Trademarks in Assignee and to aid Assignee, its successors, assigns and legal representatives to obtain and enforce proper protection for the Trademarks.
- Section 3. <u>Counterparts</u>. This Assignment may be executed in one or more identical counterparts, all of which, when taken together shall constitute one and the same instrument.
- Section 5. <u>Governing Law.</u> This Assignment shall be governed by and construed in accordance with the laws of the State of Texas.
- Section 6. <u>Partial Invalidity</u>. The provisions hereof shall be deemed independent and severable, and the invalidity or enforceability of any one provision shall not affect the validity or enforceability of any other provision hereof.
