Release of Security Interest in Trademark Rights

September 21, 2020

**WHEREAS**, reference is made to that certain (i) Security Agreement, dated as of August 2, 2018 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”), by and among Windstream Services, LLC, a Delaware limited liability company (the “**Company**”), Windstream Finance Corp., a Delaware corporation (the “**Co-Issuer**”), the Guarantors party thereto and Wilmington Trust, National Association, as Collateral Agent (the “**Collateral Agent**”) and (ii) Indenture, dated as of August 2, 2018 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Indenture**”) among the Company, as issuer, the Co-Issuer, the guarantors party thereto, Wilmington Trust, National Association, as trustee and collateral agent (in such capacity, the “**Collateral Agent**”), pursuant to which the Company will issued its 9.00% senior secured second lien notes due 2025 (the “**Notes**”);

**WHEREAS**, by a certain Trademark Security Agreement, dated as of August 2, 2018 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Agreement**”; terms used but not defined herein have the meanings ascribed thereto in the Agreement), by the Lien Grantors (as defined therein) party thereto in favor of the Collateral Agent, which Agreement was recorded with the United States Patent and Trademark Office (the “**USPTO**”) on August 6, 2018 on reel 6406 frame 0356, each Lien Grantor pledged and granted a continuing security interest in all of such Lien Grantor’s right, title and interest in, to and under the Trademark Collateral (including, without limitation, each Trademark registration and application therefor referred to in Schedule I hereto) to the Collateral Agent and its successors and assigns for the benefit of the Secured Parties; and

**WHEREAS**, the Collateral Agent has agreed at the request of the Lien Grantors to release its security interest in and lien on the Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

*SECTION 1. Release of Security Interest in Trademark Collateral.*

(a) In accordance with the instructions of the Borrower received pursuant to Section 18 of the Security Agreement and Section 10.04 of the Indenture, the Collateral Agent hereby terminates the Agreement and the Collateral Agent hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademark Collateral and any property related thereto.

(b) If and to the extent the Collateral Agent has acquired any right, title or interest in, to or under any of the Trademark Collateral or any property related thereto, the Collateral Agent hereby assigns, transfers, conveys and delivers such right, title or interest to the Grantors.

(c) The Collateral Agent shall take all further actions, and provide to each Lien Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Lien Grantor to more fully and effectively effectuate the purposes of this Release of Security Interest in Trademark Rights, in each case at the Lien Grantors' sole expense.

(d) The Collateral Agent acknowledges and affirms that upon execution hereof, it shall have no rights and remedies with respect to the Trademark Collateral or any other property related thereto.

SECTION 2. *Recordation of Release.* The Collateral Agent hereby authorizes and requests that the Commissioner for Trademarks in the USPTO, and any other necessary United States government officer, record this Release of Security Interest in Trademark Rights; it being understood that such recordation shall be at the Lien Grantors' sole expense.


SECTION 3. *Counterparts.* This Release of Security Interest in Trademark Rights may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

SECTION 4. *Governing Law.* This Release of Security Interest in Trademark Rights shall be governed by and construed in accordance with the laws of the State of New York.
