### TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment"), dated as of October 23, 2020, is entered into between RADISSON HOTELS INTERNATIONAL, INC., a corporation of Delaware, United States of America with its place of business at Carlson Parkway, P.O.
