**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of September 15, 2020 (this “Release”), is granted by Bank of America, N.A., a National Bank association located at 135 South LaSalle Street, 4th Floor, Chicago, Illinois, 60603, in its capacity as agent (in such capacity, together with its successors and assigns in such capacity, “Agent”) in favor of the grantor parties identified on Annex A hereto (collectively, jointly and severally, “Grantors” and each individually “Grantor”).

WHEREAS, School Specialty, Inc. (the “Company”), as Borrower Agent, Borrower and a Guarantor, the subsidiaries of Company party thereto as Borrowers, the subsidiaries of the Company party thereto as Guarantors, the Lenders party thereto and Agent, are parties to a Loan Agreement dated as of June 11, 2013 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Loan Agreement”).

WHEREAS, the Grantors executed and delivered for recordation with the U.S. Patent and Trademark Office (the “USPTO”) the trademark security agreements set forth on Annex B hereto (together, the “Trademark Security Agreements”).

WHEREAS, pursuant to the Trademark Security Agreements, each Grantor granted to Agent a continuing security interest in all of Grantor's right, title and interest in, to and under the Trademark Collateral (as defined in the applicable Trademark Security Agreement), whether then owned by Grantor or existing or thereafter acquired or arising.

WHEREAS, the Trademark Security Agreements were recorded with the USPTO at the Reel and Frame numbers set forth on Annex B hereto.

WHEREAS, the Grantors and the other Loan Parties have caused the Full Payment of all Obligations under the Loan Documents, and as a result, Agent has agreed to terminate and release its security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor and Agent hereby agree as follows:

SECTION 1. Defined Terms. Capitalized terms used but not otherwise defined herein shall have the meanings ascribed in or otherwise referenced in the Trademark Security Agreements or, if not defined or otherwise referenced therein, such terms shall have the meanings ascribed in the Loan Agreement.

SECTION 2. Termination and Release. Agent, on behalf of itself and the Credit Parties, without recourse, representation or warranty of any kind or nature, hereby (a) terminates, releases and discharges fully its security interest in all of the Grantor's right, title and interest in, to and under all of the Trademark Collateral, including the Trademark Collateral set forth on Annex C hereto, (b) terminates all of Agent's and the Credit Parties' right, title and interest in, to and under such Trademark Collateral and (c) at the sole cost and expense of the Company,

agrees to duly execute and deliver any further documents and do such other acts as may be reasonably necessary to effect the release of such security interest, as may be reasonably requested in writing by the Company from time to time.

SECTION 3. Recordation. Agent, on behalf of itself and the Credit Parties, authorizes and requests the recordation of this Release against the Trademark Collateral with the USPTO and any other applicable Governmental Authority at the Grantor's expense.

SECTION 4. GOVERNING LAW. THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK WITHOUT REGARD TO CONFLICTS OF LAWS PRINCIPLES THEREOF BUT INCLUDING SECTIONS 5-1401 AND 5-1402 OF THE NEW YORK GENERAL OBLIGATIONS LAW.

SECTION 5. Miscellaneous. This Release shall be binding upon Agent's and the Credit Parties' representatives, successors, assigns and transferees and is made in favor of and for the benefit of each of the Grantors and its successors and assigns.
