NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS

This Notice of Grant of Security Interest in Trademark Rights (this "Agreement") dated as of October 30, 2020, is given by COASTAL FARM & HOME SUPPLY LLC, an Oregon limited liability company ("Grantor"), in favor of U.S. BANK NATIONAL ASSOCIATION, as Administrative Agent ("Administrative Agent"), located at 1420 Fifth Avenue, 11th Floor, Seattle, WA 98101.

1. Definitions

2. Grant of Security Interest

Grantor hereby pledges and grants a continuing security interest in, and a right of setoff against, and, except as set forth below, effective upon demand made upon the occurrence and during the continuance of an Event of Default, assigns, transfers and conveys the trademarks listed on Schedule A attached hereto, and the associated goodwill (collectively, the "Trademark Collateral"), to Administrative Agent, for the benefit of Lenders, to secure payment, performance and observance by Grantor of its obligations under the Loan Agreement and the other Loan Documents (as such term is defined in the Loan Agreement). Under no circumstance, including upon the occurrence of or during the continuance of an Event of Default, shall any pending Intent to Use trademark applications of Grantor ("ITUs") be assigned, transferred or conveyed to Administrative Agent under Section 2 of this Agreement or otherwise, prior to the completion of the registration process and issuance of any registration relating to any such ITU.
