**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made effective as of November 2, 2020, by and from JPMORGAN CHASE BANK, N.A., as administrative agent for the Secured Parties (in such capacity, together with its successors and assigns in such capacities, the “Administrative Agent”), in favor of MOMENTIVE PERFORMANCE MATERIALS HOLDINGS INC., a Delaware corporation, located at 260 Hudson River Road, Waterford, New York 12188 (“Holdings”), MOMENTIVE PERFORMANCE MATERIALS GMBH & CO KG, a company organized under the laws of Germany, located at Chempark, Gebäude V 7, 51368 Leverkusen, Germany (“MPM KG”), and MOMENTIVE PERFORMANCE MATERIALS JAPAN HOLDINGS GK, a company organized under the laws of Japan, located at 19 Floor, 5-2-20 Akasaka, Minato-ku, Tokyo, 107-6109 Japan (together, with Holdings and MPM KG, each a “Grantor” and collectively, the “Grantors”). Capitalized terms used herein and not otherwise herein defined have the meanings set forth in the Trademark Security Agreement.

WHEREAS, Grantors and the Administrative Agent are parties to that certain Trademark Security Agreement, dated as of February 28, 2007 (as amended, restated, supplemented, waived or otherwise modified from time to time, the “Trademark Security Agreement”), pursuant to which the Grantors have granted to the Administrative Agent (for the benefit of the Secured Parties) a security interest in the Trademark Collateral, including the trademark registrations and trademark applications set forth on Schedule I attached hereto (the “Scheduled Trademarks”); and

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office (“USPTO”) on July 2, 2007 at Reel/Frame 03572/0690; and

WHEREAS, the Grantors have requested that the Administrative Agent release, and the Administrative Agent hereby confirms the termination and release of such security interest in and to all Trademark Collateral, including the Scheduled Trademarks, in accordance with the terms of this Release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. Release of Security Interest. The Administrative Agent hereby confirms the unconditional and irrevocable termination, release, and discharge of the security interest in or to the Trademark Collateral, including the Scheduled Trademarks, arising under the Trademark Security Agreement. If and to the extent the Administrative Agent has acquired any right, title or interest in or to the Scheduled Trademarks, the Administrative Agent hereby confirms the re-assignment and re-transfer to the Grantors, without recourse, of all such right, title and interest.


2. Authorization to Record. The Administrative Agent authorizes and requests that the USPTO record this Release.
