**RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS is made as of November 12, 2020, by ARES CAPITAL CORPORATION, a Maryland corporation ("Collateral Agent") in favor of IBIS, LLC, a New Hampshire limited liability company ("Grantor"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Pledge Agreement (as defined below).

WITNESSETH:

WHEREAS, Grantor, the other parties hereto from time to time, and Collateral Agent were parties to that certain Second Lien Security Pledge Agreement dated as of November 17, 2016 (the "Security Pledge Agreement") pursuant to which Grantor granted a security interest to Collateral Agent in certain Trademarks as security for certain obligations owing by Grantor to Collateral Agent;

WHEREAS, pursuant to the Security Pledge Agreement, the Grantor executed the Second Lien Grant of Security Interest in Trademark Rights dated as of January 15, 2020 ("Trademark Security Agreement") and recorded with the Trademark Division of the United States Patent and Trademark Office on January 17, 2020, at Reel 6840, Frame 0319;

WHEREAS, pursuant to the terms and conditions of the Trademark Security Agreement, Grantor granted to the Collateral Agent, a security interest in, and a right of setoff against (the "Security Interest"), Grantor's right, title, and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including the trademarks set forth on Schedule I (the "Released Collateral");

WHEREAS, Grantor has satisfied and fulfilled all of its obligations to release the Collateral Agent's security interest in the Trademark Collateral; and


WHEREAS, Grantor has requested that Collateral Agent release the security interest in the Released Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates, releases and forever discharges the Trademark Security Agreement and the Security Interest in the Released Collateral, and retransfers and reassigns to Grantor any right, title or interest the Collateral Agent may have in, to or under the Grantor's Released Collateral.
