## INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT ("*IP Security Agreement*"), dated as of August 7, 2020, is made by and between **DKH RETAIL LIMITED**, a company registered in England and Wales with number 07063508 (the "*Grantor*") in favor of **HSBC INVOICE FINANCE (UK) LIMITED**, a company registered in England and Wales with number 00759637 as security trustee for the Secured Parties (as defined in the Debenture, defined below (the "*Security Agent*").

WHEREAS, the Grantor, Superdry plc, the companies listed in parts 1 to 3 of schedule 1 therein, as Original Companies, the subsidiaries of Superdry plc listed in Part 4 of Schedule 1 therein as Original Guarantors, HSBC Invoice Finance (UK) Limited and BNP Paribas, as Arrangers, the financial institutions listed in Part 2 of Schedule 1 therein, as Original Lenders ("*Lenders*"), HSBC Invoice Finance (UK) Limited, as Agent and the Security Agent dated as of August 7, 2020 (the "*ABLA*").

WHEREAS, as a condition precedent to the making of the loans by the Lenders under the ABLA, Grantor has executed and delivered to the Security Agent that certain Debenture dated as of August 7, 2020, made by and among Superdry plc, the Grantor, and the persons listed in Schedule 1 attached thereto and the Security Agent (the "*Debenture*").

WHEREAS, under the terms of the Debenture, the Grantor has granted to the Security Agent, for the benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Grantors, and has agreed to execute and deliver this IP Security Agreement for recording with governmental authorities, including, but not limited to, the United States Patent and Trademark Office and the United States Copyright Office.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided (or incorporated by reference) in the Debenture.

2. Grant of Security. Grantor hereby pledges and grants to the Security Agent for the ratable benefit of the Secured Parties a security interest in and to all of the right, title, and interest of Grantor in, to, and under the following (the "*IP Collateral*");

(a) the patents and patent applications set forth in Schedule 1 hereto and all reissues, divisions, continuations, continuations-in-part, renewals, extensions, and reexaminations thereof and amendments thereto (the "*Patents*");

(b) the trademark registrations and applications set forth in Schedule 1 hereto, together with the goodwill connected with the use thereof and symbolized thereby, and all extensions and renewals thereof (the "*Trademarks*");

(c) the copyright registrations and applications, and copyright registrations and applications exclusively licensed to Grantor set forth in Schedule I hereto, and all extensions and renewals thereof (the "*Copyrights*");

(d) all rights of any kind whatsoever of Grantor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

(e) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(f) any and all claims and causes of action with respect to any of the foregoing, whether occurring before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right, but no obligation, to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

3. Recordation. Grantor will, at its own expense, make, execute, endorse, acknowledge, file and/or deliver to the Security Agent and authorize the Security Agent to file such financing statements, such patent, trademark and copyright filings and such other filings, in form reasonably acceptable to the Security Agent, as the Security Agent may from time to time reasonably request and as are necessary or appropriate in the reasonable opinion of the Security Agent to establish and maintain a valid, enforceable, perfected security interest in the IP Collateral as provided herein and priority thereof and the other rights and security contemplated hereby. Grantor hereby authorizes the Security Agent to file any such financing statements, continuation statements, filings with the United States Patent and Trademark Office or United States Copyright Office (or any successor office or any similar office in any other country) or other documents, without the signature of such Grantor where permitted by law. Grantor authorizes the Commissioner for Patents, the Commissioner for Trademarks, and the Register of Copyrights, and any other government officials to record and register this IP Security Agreement upon request by the Security Agent.

4. Loan Documents. This IP Security Agreement has been entered into pursuant to and in conjunction with the Debenture, which is hereby incorporated by reference. The provisions of the ABLA and Debenture shall supersede and control over any conflicting or inconsistent provision herein. The rights and remedies of the Security Agent with respect to the IP Collateral are as provided by the ABLA, the Debenture, and related documents, and nothing in this IP Security Agreement shall be deemed to limit such rights and remedies.

5. Execution in Counterparts. This IP Security Agreement may be executed in counterparts (and by different parties hereto in different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page to this IP Security Agreement by

facsimile or in electronic (i.e., "pdf" or "tif") format shall be effective as delivery of a manually executed counterpart of this IP Security Agreement.


6. Successors and Assigns. This IP Security Agreement will be binding on and shall inure to the benefit of the parties hereto and their respective successors and assigns.

7. Governing Law. This IP Security Agreement and any claim, controversy, dispute, or cause of action (whether in contract or tort or otherwise) based upon, arising out of, or relating to this IP Security Agreement and the transactions contemplated hereby and thereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).
