This NOTICE OF SUCCESSION OF AGENCY (this "Notice"), dated as of November 13, 2020 (the "Effective Date"), is executed by Credit Suisse AG, Cayman Islands Branch, in its capacity as Collateral Agent under the Credit Agreement, the Indenture, the First Lien Intercreditor Agreement, the Collateral Agreement, the other Secured Credit Documents and the other First Lien Security Documents (each as defined in the Successor Agency Agreement (as defined below)) (the "Prior Agent") and U.S. Bank National Association, in its capacity as Successor Collateral Agent under the Successor Agency Agreement) (the "Successor Agent").

WHEREAS, pursuant to that certain Credit Agreement, dated as of December 22, 2017 (as amended by the First Amendment to Credit Agreement, dated as of June 15, 2020, Incremental Assumption Agreement No. 1, dated as of July 20, 2020, Incremental Assumption Agreement No. 2, dated as of July 20, 2020, and as further amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the "Credit Agreement"), by and among Caesars Resort Collection, LLC (the "Borrower Representative"), the other borrowers from time to time party thereto, the lenders from time to time party thereto, Credit Suisse AG, Cayman Islands Branch, as administrative agent, and the Prior Agent, the Prior Agent and certain grantor parties identified on the signature page thereto (the "Grantors") entered into (i) that certain Collateral Agreement, dated as of December 22, 2017 (as supplemented by Supplement No. 1, dated as of July 16, 2018, Supplement No. 2, dated as of July 20, 2020, and as further amended, restated, amended and restated, supplemented or otherwise modified prior to the date hereof, the "Collateral Agreement"), (ii) the Trademark Security Agreement, dated as of December 22, 2017 (as partially released on December 5, 2019 and October 9, 2020, the "2017" Trademark Security Agreement"), among the Prior Agent and the applicable Grantors, (iii) the Trademark Security Agreement, dated as of July 16, 2018 (the "2018 Trademark Security Agreement"), among the Prior Agent and the applicable Grantors and (iv) the Trademark Security Agreement, dated as of July 20, 2020 (the "2020 Trademark Security Agreement" and, together with the 2017 Trademark Security Agreement and the 2018 Trademark Security Agreement, the "Trademark Security Agreements"), among the Prior Agent and the applicable Grantors, in each case, pursuant to which the applicable Grantors granted a security interest in and to certain collateral;

Nothing herein shall be deemed to terminate, interrupt or impair the continuity of the security interest in the collateral originally granted to the Prior Agent under the Trademark Security Agreements, which security interest is now succeeded by and transferred to the Successor Agent.
