Under Section 803 of the Not-for-Profit Corporation Law

FIRST: The name of the corporation is ACCION East, Inc. (the "Corporation") The name under which the Corporation was formed is ACCION New York, Inc.

SECOND: The Certificate of Incorporation of the Corporation was filed with the Department of State on January 30, 1996.

THIRD: The Corporation was formed under the Not-for-Profit Corporation Law of the State of New York.

FOURTH: The Corporation is a corporation as defined in subparagraph (5) of paragraph (a) of Section 102 of the Not-for-Profit Corporation Law.

FIFTH: The Certificate of Incorporation of the Corporation is hereby amended to effect a change in the name of the Corporation, pursuant to Section 801 of the Not-for-Profit Corporation Law.

SIXTH: To accomplish the foregoing amendment, Article FIRST of the Certificate of Incorporation relating to the name of the Corporation is amended to read in its entirety as follows:

"FIRST: The name of the corporation is Ascendus, Inc. (the "Corporation")."

SEVENTH: This Certificate of Amendment of Certificate of Incorporation was authorized at a meeting of the Board of Directors at which a quorum was present, by the vote of at least a majority of the entire Board of Directors, the Corporation having no members entitled to vote on said amendment.
