### TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (this "<u>Agreement</u>") is made as of November 19, 2020, by the entities listed on the signature pages hereof as "Grantors" (collectively, "<u>Grantors</u>" and each, individually, a "<u>Grantor</u>") in favor of FIFTH THIRD BANK, NATIONAL ASSOCIATION, in its capacity as agent under the Credit Agreement described below ("<u>Agent</u>").

### WITNESSETH

WHEREAS, iHerb, LLC, a Delaware limited liability company ("<u>Borrower</u>"), the other Loan Parties from time to time party thereto, the financial institutions or other entities from time to time party thereto (collectively, "<u>Lenders</u>") and Agent have entered into that certain Credit Agreement of even date herewith (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "<u>Credit Agreement</u>"), providing for the extensions of credit to be made to Borrower by Agent and Lenders, subject to the terms and conditions set forth therein;

WHEREAS, in order to induce Agent and Lenders to make the loans and other financial accommodations provided for in the Credit Agreement and in consideration of the foregoing and for other good and valuable consideration, Grantors, certain affiliates of Grantors and Agent have entered into that certain Guaranty and Security Agreement of even date herewith (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"); and

WHEREAS, pursuant to the terms of the Security Agreement, each Grantor has granted to Agent, for its benefit and the benefit of the Lenders, a security interest in substantially all of the assets of such Grantor, including all right, title and interest of such Grantor in, to and under all now owned and hereafter acquired or arising: (a) all trademarks, trade names, corporate and, as applicable, limited liability company names, business names, trade styles, service marks, logos, other source or business identifiers, prints and labels on which any of the foregoing have appeared or appear, designs and general intangibles of like nature (whether registered or unregistered), all registrations and recordings thereof, and all applications in connection therewith, including registrations, recordings and applications in the United States Patent and Trademark Office or in any similar office or agency of the United States, any state or territory thereof, or any other country or any political subdivision thereof; (b) all reissues, extensions or renewals thereof; (c) all goodwill associated with and symbolized by any of the foregoing ((a) through (c), collectively, "Trademarks"); and (d) all products and proceeds thereof, to secure the payment of all amounts owing by such Grantor under the Credit Agreement and the other Loan Documents;

NOW, THEREFORE, in consideration of the premises set forth herein and for other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, each Grantor agrees as follows:

1. <u>Incorporation of Credit Agreement and Security Agreement</u>. The Credit Agreement and the Security Agreement and the terms and provisions thereof are hereby incorporated

herein in their entirety by this reference thereto. All terms capitalized but not otherwise defined herein shall have the same meanings herein as in the Credit Agreement or Security Agreement, as applicable.

- 2. <u>Grant and Reaffirmation of Grant of Security Interests</u>. To secure the complete and timely payment and satisfaction of the Obligations, each Grantor hereby grants to Agent, for its benefit and the benefit of Lenders, and hereby reaffirms its grant pursuant to the Security Agreement of, a continuing security interest in such Grantor's entire right, title and interest in and to the following, whether now owned or existing or hereafter created or acquired:
- a) each Trademark listed on <u>Schedule 1</u> annexed hereto, together with any reissues, extensions and renewals thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and
- b) all products and proceeds of the foregoing, including without limitation, any claim by such Grantor against third parties for past, present or future (i) income, royalties or other payments now or hereafter due and/or payable in connection with any Trademark, (ii) damages and payments for infringements or dilution of any of Trademark, and (iii) the right to sue for past, present and future infringement or dilution of any Trademark.

Notwithstanding the foregoing, no security interest shall be granted in any Excluded Property.

- 3. New Trademarks. If, before the Obligations (other than contingent indemnification obligations for which no claim has been asserted) shall have been satisfied in full, any Grantor shall (i) become aware of any federally registered Trademarks (other than Excluded Property) held by such Grantor of which such Grantor has not previously informed Agent, or (ii) become entitled to the benefit of any federally registered Trademarks (other than Excluded Property) held by such Grantor, which benefit is not in existence on the date hereof, the provisions of this Agreement shall automatically apply thereto and such Grantor shall give to Agent written notice thereof in accordance with the terms of Annex E to the Credit Agreement. Each Grantor hereby authorizes Agent to modify this Agreement by amending Schedule 1 to include any such Trademarks (other than Excluded Property).
- Miscellaneous. THIS AGREEMENT SHALL BE GOVERNED BY, 4. AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK WITHOUT REGARD TO CONFLICTS OF LAWS PRINCIPLES. Whenever possible each provision of this Agreement shall be interpreted in such manner as to be effective and valid under applicable law, but in case any provision of or obligation under this Agreement shall be invalid, illegal, or unenforceable in any jurisdiction, the validity, legality, and enforceability of the remaining provisions or obligations, or of such provision or obligation in any other jurisdiction, shall not in any way be affected or impaired thereby. Whenever in this Agreement reference is made to Agent, Lenders, or Grantors, such reference shall be deemed to include, as applicable, a reference to their respective successors and assigns. The provisions of this Agreement shall be binding upon Grantors and their respective successors and assigns, and shall inure to the benefit of Agent, Lenders and their respective successors and assigns. This Agreement is primarily for the purposes of recording in the United States Patent and Trademark Office. To the extent of any conflict between this Agreement and the Security Agreement, the provisions of the Security Agreement shall control.

This Agreement may be executed in any number of counterparts, all of which shall, collectively and separately, constitute one agreement, each of which shall constitute an original, but all of which taken together shall be one and the same instrument. Delivery by telecopy or electronic portable document format (i.e., "pdf") transmission of executed signature pages hereof from one party hereto to another party hereto shall be deemed to constitute due execution and delivery by such party.
