

#### RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

WHEREAS, in accordance with the terms set forth in the Credit Agreement, Secured Party now wishes to release any and all interest it may have in the patents and patent applications listed on Schedule A attached hereto, and patents, patent applications, reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations owned by the Debtor (collectively, the "Released Patents"), the trademark and service mark registrations and applications listed on Schedule B attached hereto, and any trademarks, trademark applications, extensions, renewals and common law trademarks owned by the Debtor, including any goodwill associated therewith (collectively, the "Released Trademarks"), the copyright registrations listed on Schedule C attached hereto, and any copyright registrations, copyright applications, extensions, renewals and unregistered copyrights owned by the Debtor (collectively the "Released Copyrights"), any and all claims for damages and injunctive relief for past, present and future infringement of any of the foregoing, and all income, royalties and other payments now or hereafter due and payable with respect to any and all of the foregoing, and, to the extent encumbered by the above-referenced security interests, all domain names listed on Schedule D and any domain names owned by Debtor (the "Released Domain Names"), and the licenses listed in Schedule E (the "Released Licenses"), the foregoing collectively hereinafter referred to as the Released Intellectual Property.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Secured Party hereby states as follows:

SECTION 1. <u>Terms</u>. Each capitalized term used but not otherwise defined herein shall have the meaning specified in the Credit Agreements.

SECTION 2. <u>Release of Security Interest</u>. The Secured Party, without representation or warranty of any kind, hereby irrevocably terminates, releases and discharges, without recourse or warranty, all liens on and security interests in and to all of the right, title and interest of the Secured Party in, to and under the Released Intellectual Property.

SECTION 3. <u>Authorization</u>. The Secured Party hereby authorizes and requests the Commissioner for Patents and the Commissioner for Trademarks of the USPTO, the Register of Copyrights of the USCO, and any other applicable government officer or relevant governmental authority, to record this Release.

#### SECTION 5. General Provisions.

- 5.1 This Release may not be modified, nor may any provision hereof be waived, orally or in any manner other than by an agreement in writing signed by the parties hereto or their respective successors and assigns.
- 5.2 All rights hereunder shall accrue to, and all obligations hereunder shall be binding upon, the heirs, representatives, successors, assigns and transferees of the parties hereto.
