INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT, effective as of October 1, 2020 (this "<u>Agreement</u>"), is entered into by and between Kona Brewery LLC, a Hawaii limited liability company ("<u>Assignor</u>") and Craft Brew Alliance, Inc., a Washington Corporation ("<u>Assignee</u>") (each a "<u>Party</u>"). Capitalized terms used but not otherwise defined herein shall have the meaning set forth in the Purchase Agreement (as defined below).

WITNESSETH:

WHEREAS, Assignor, Assignee and PV Brewing Partners, LLC have entered into that certain Membership Interest Purchase Agreement, dated as of June 10, 2020 (the "<u>Purchase Agreement</u>"), pursuant to which, among other things, the parties thereto agreed that Assignor and Assignee would effect the Pre-Closing Reorganization prior to the Closing; and

WHEREAS, as part of the Pre-Closing Reorganization, the Parties desire to execute and deliver this Agreement evidencing and effecting the assignment, transfer, conveyance and delivery to Assignee of Assignor's right, title and interest in, to and under the Excluded IP Rights.

NOW, THEREFORE, in consideration of the premises and the mutual covenants and the agreements set forth herein, in the Purchase Agreement and in the Transaction Documents, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties, intending to be legally bound, hereby agree as follows:

Section 1. <u>Assignment</u>. Effective as of immediately prior to the Closing, Assignor hereby irrevocably assigns, transfers and conveys to Assignee all of Assignor's right, title and interest in, to and under all of the Excluded IP Rights, including (a) all rights to sue for and recover and retain damages for present, past and future infringement, misappropriation or other violation thereof, and (b) the Registered Intellectual Property Rights set forth on Schedule A (with respect to any Trademark included in such Registered Intellectual Property Rights, including all goodwill associated therewith and symbolized thereby). Effective as of immediately prior to the Closing, Assignee hereby accepts and acquires from Assignor all of Assignor's right, title and interest in, to and under such Excluded IP Rights.

Section 2. <u>Recordation</u>. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States, the Office of the Register of Copyrights of the United States, the Commissioner of the Department of Commerce and Consumer Affairs of Hawaii and any official of any other jurisdiction or organization (including any foreign jurisdiction or organization) whose duty is to issue any applicable Intellectual Property Right or any legal equivalent thereof, to record and register Assignee as the assignee and owner of all right, title and interest in, to and under the applicable Excluded IP Rights.

Section 3. <u>Further Assurances</u>. Upon the request of Assignee, Assignor shall promptly execute any other documents and take any other actions reasonably required to give Assignee the full benefit of this Agreement, the Pre-Closing Reorganization and the assignments set forth in <u>Section 1</u>, including any such documents required to perfect and record such assignments in any applicable filing jurisdictions.

Section 4. No Third Party Beneficiaries. Subject to the last sentence of this Section 4, there shall be no third party beneficiaries of this Agreement, and this Agreement shall not confer on any Person other than the Parties any claim, cause of action, right or remedy. Notwithstanding the foregoing or anything to the contrary in this Agreement, (a) the Parties shall not modify or amend this Agreement or waive compliance with any term or provision of this Agreement in any manner without the prior written consent of ABC, and (b) without limiting the generality of the immediately preceding clause (a), ABC shall be an express third party beneficiary of this Agreement.

Section 5. <u>Successors and Assigns</u>. This Agreement shall be binding upon and shall inure to the benefit of the Parties and their respective successors, legal Representatives and assigns.

Section 6. Entire Agreement; Subject to Purchase Agreement. This Agreement, the Purchase Agreement and the Transaction Documents contain and constitute the entire agreement of the Parties with respect to the subject matter hereof and supersede all prior negotiations, agreements and understandings, whether written or oral, of the Parties. The scope, nature, and extent of the Excluded IP Rights are expressly set forth in the Purchase Agreement. Nothing contained in this Agreement shall itself change, amend, extend or alter (nor shall it be deemed or construed as changing, amending, extending or altering) the terms or conditions of the Purchase Agreement in any manner whatsoever. This Agreement does not create or establish liabilities or obligations not otherwise created or existing under or pursuant to the Purchase Agreement. In the event of any inconsistency between the Purchase Agreement and this Agreement, the provisions of the Purchase Agreement shall govern and control. The Parties acknowledge and agree that the representations, warranties, covenants, agreements, conditions and indemnities contained in the Purchase Agreement will not be superseded hereby but will remain in full force and effect to the full extent provided therein.

Section 7. Governing Law. This Agreement, and any Action (whether in contract, tort or statute) that may directly or indirectly be based upon, relate to or arise out of this Agreement, or the negotiation, execution or performance of this Agreement, shall be governed by, and construed and enforced in accordance with, the Laws of the State of Delaware, without regard to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction) that would cause the application of the Laws of any jurisdiction other than the State of Delaware.

Section 8. <u>Amendment; Modification; Waiver</u>. Subject to the provisions of applicable Law, this Agreement may be amended or otherwise modified or waived if, and only if, such amendment or other modification by Assignor or Assignee, or in the case of a waiver, by the Party against whom the waiver is to be effective. No failure or delay by any Party in exercising any right, power or privilege hereunder shall operate as a waiver thereof nor shall any single or partial exercise thereof preclude any other or further exercise thereof or the exercise of any other right, power or privilege. The rights and remedies herein provided shall be cumulative and not exclusive of any rights or remedies provided by Law.

Section 9. <u>Interpretation; Construction</u>. <u>Section 8.9</u> of the Purchase Agreement shall apply *mutatis mutandis* to this Agreement.

Section 10. <u>Counterparts</u>. This Agreement may be executed in any number of counterparts, each such counterpart being deemed to be an original instrument, and all such counterparts shall together constitute the same agreement. Delivery of an executed counterpart of a signature page to this Agreement by facsimile transmission or by email of a .pdf attachment shall be effective as delivery of a manually executed counterpart of this Agreement.
