PARTIAL RELEASE OF INTELLECTUAL PROPERTY SECURITY INTERESTS dated as of December 9, 2020 (this "Partial Release"), by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as Collateral Agent (as defined below), in favor of Nutrisystem, Inc., a Delaware corporation, and SBD Enterprises, LLC, a Delaware limited liability company (each, a "Grantor" and, together, the "Grantors"). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Security Agreement, as applicable, referred to below.

- Reference is made to (i) that certain Credit and Guaranty A. Agreement, dated as of March 8, 2019 (as amended, restated, amended and restated, modified or otherwise supplemented from time to time, the "Credit Agreement"), among Tivity Health, Inc., a Delaware corporation (the "Borrower"), certain Subsidiaries of the Borrower from time to time party thereto, the lenders from time to time party thereto, Credit Suisse AG, Cayman Islands Branch, as general administrative agent (in such capacity, the "Administrative Agent"), term facility agent and Collateral Agent (as defined herein), and Truist Bank (formerly known as SunTrust Bank), as revolving facility agent and swing line lender, (ii) that certain Pledge and Security Agreement, dated as of March 8, 2019 (as amended, restated, amended and restated, modified or otherwise supplemented from time to time, the "Security Agreement"), among the Borrower, certain Subsidiaries of the Borrower from time to time party thereto, and Credit Suisse AG, Cayman Islands Branch, as collateral agent (in such capacity, the "Collateral Agent") for the Secured Parties, and (iii) the Trademark Security Agreement dated as of April 15, 2019, among the grantors listed therein and the Collateral Agent (the "Trademark Security Agreement" and such documents set forth in clauses (i) through (iii), the "Security Documents").
- B. Pursuant to the Security Documents, SBD Enterprises, LLC, granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all right, title or interest of SBD Enterprises, LLC, in, among other things, the trademarks and trademark applications set forth on Schedule I hereto under the heading "Trademarks Owned by SBD Enterprises, LLC" (collectively, the "SBD Released Trademark Collateral"), which security interests were recorded with the United States Patent and Trademark Office on April 17, 2019, at Reel/Frame 6621/0585.
- C. Pursuant to the Security Documents, Nutri/System IPHC, Inc., a Delaware corporation, granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all right, title or interest of Nutri/System IPHC, Inc., in, among other things, the trademarks and trademark applications set forth on Schedule I hereto under the heading "Trademarks Owned by Nutri/System IPHC, Inc. (assigned to Nutrisystem, Inc.)" (collectively, the "Nutrisystem Released Trademark Collateral" and, together with the SBD Released Trademark Collateral, the "Released Trademark Collateral"), which security interests were recorded with the United States Patent and Trademark Office on April 17, 2019, at Reel/Frame 6621/0585. Pursuant to an Intellectual Property Assignment Agreement, dated as of May 31, 2019, by Nutri/System IPHC, Inc.,

in favor of Nutrisystem, Inc., Nutri/System IPHC, Inc., irrevocably conveyed, transferred and assigned to Nutrisystem, Inc., all of Nutri/System IPHC, Inc.'s right, title and interest in and to, among other things, the Nutrisystem Released Trademark Collateral, which assignment was recorded with the United States Patent and Trademark Office on July 12, 2019, at Reel/Frame 6692/929, and on February 4, 2020, at Reel/Frame 6855/625.

D. The Borrower has notified the Collateral Agent that the Borrower intends to sell all of the outstanding capital stock of Nutrisystem, Inc., which holds all of the outstanding capital stock of SBD Enterprises, LLC.

Pursuant to Section 9.8 of the Credit Agreement and Section 6.14 of the Security Agreement, and acting in reliance upon that certain Officer's Certificate dated as of the date hereof, the Collateral Agent does hereby release, relinquish and discharge any and all security interests it has against the Released Trademark Collateral, and hereby reassigns to the respective Grantor any and all right, title and interest that the Collateral Agent may have in or to such Released Trademark Collateral; provided, however, that it is understood and agreed that such release, relinquishment and discharge will be without recourse, representation or warranty of any kind (express or implied).

This Partial Release is applicable only and solely with respect to the Released Trademark Collateral and to no other collateral arising under the Trademark Security Agreement or the Security Agreement (the "Retained Collateral"). The Collateral Agent retains all security interests, liens, rights, titles and interests pledged and granted to it under the Trademark Security Agreement and the Security Agreement with respect to all such Retained Collateral, and the Collateral Agent's security interest, liens, rights, titles and interests in such Retained Collateral shall not, and shall not be deemed to, be impaired, interrupted or otherwise modified in any respect by this Partial Release. Except as expressly modified hereby, the Trademark Security Agreement and the Security Agreement shall remain in full force and effect, each in accordance with the provisions thereof on the date thereof.

The Collateral Agent authorizes each of the Borrower and the Grantors and their respective successors, assigns or other legal representatives to make filings with the United States Patent and Trademark Office and other necessary filings, in each case at the expense of the Borrower, to evidence the release and termination of the Collateral Agent's security interests in the Released Trademark Collateral.

THIS PARTIAL RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE COLLATERAL AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
