

GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS

This GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS ("<u>Agreement</u>"), effective as of September 21, 2020 is made by UHS OF DELAWARE, INC., a Delaware corporation located at 367 South Gulph Road, King of Prussia, Pennsylvania 19406, (the "<u>Obligor</u>"), in favor of JPMORGAN CHASE BANK, N.A., a national banking association located at 10 S. Dearborn, 7th Floor, Chicago, IL 60603 as Collateral Agent (the "<u>Collateral Agent</u>") for the Secured Parties.

WHEREAS, pursuant to the Credit Agreement dated as of November 15, 2010 (as amended, supplemented or otherwise modified from time to time, the "<u>Credit Agreement</u>"), among Universal Health Services, Inc., a Delaware Corporation ("<u>Borrower</u>"), the several banks and other financial institutions (the "<u>Lenders</u>") parties thereto, the Administrative Agent and the other agents named therein, the Lenders have severally agreed to make Loans and other extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein; and

WHEREAS, in connection with the Credit Agreement, the Borrower and certain of its Affiliates (including the Obligor), have entered into that certain Amended and Restated Collateral Agreement, dated as of August 7, 2014 (as amended, supplemented or otherwise modified from time to time, the "Collateral Agreement"), in favor of the Collateral Agent for the ratable benefit of the Secured Parties:

WHEREAS, pursuant to the Collateral Agreement, the Borrower and certain of its Affiliates, including the Obligor pledged and granted to the Collateral Agent for the benefit of the Collateral Agent, for the ratable benefit of the Secured Parties, a continuing security interest in all Intellectual Property, including the Trademarks; and

WHEREAS, the Obligor and Borrower have duly authorized the execution, delivery and performance of this Agreement;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in order to induce the Lenders to make Loans and other financial accommodations to the Borrower pursuant to the Credit Agreement, the Obligor agrees, for the benefit of the Secured Parties, as follows:

SECTION 1. <u>Definitions</u>. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided or provided by reference in the Credit Agreement and the Collateral Agreement.

SECTION 2. <u>Grant of Security Interest</u>. The Obligor hereby pledges and grants a continuing security interest in all of Obligor's right, title and interest in, to and under the Trademarks (including, without limitation, those items listed on <u>Schedule A</u> hereto) (collectively, the "<u>Collateral</u>"), to the Collateral Agent for the benefit of the Collateral Agent and the Lenders to secure payment, performance and observance of the Obligations.

SECTION 3. <u>Purpose</u>. This Agreement has been executed and delivered by the Obligor for the purpose of recording the grant of security interest herein with the United States

Patent and Trademark Office. The security interest granted hereby has been granted to the Lenders in connection with the Collateral Agreement and is expressly subject to the terms and conditions thereof. The Collateral Agreement (and all rights and remedies of the Lenders thereunder) shall remain in full force and effect in accordance with its terms.

SECTION 4. <u>Acknowledgment</u>. The Obligor does hereby further acknowledge and affirm that the rights and remedies of the Collateral Agent with respect to the security interest in the Collateral granted hereby are more fully set forth in the Credit Agreement and the Collateral Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the terms of the Collateral Agreement, the terms of the Collateral Agreement shall govern.

SECTION 5. <u>Counterparts</u>. This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
