PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

This PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of December 14, 2020, by Credit Suisse AG, Cayman Islands Branch, as collateral agent (the "Collateral Agent"), in favor of Potters Industries, LLC, (the "PI LLC"). Capitalized terms used but not defined herein have the meanings specified (including by reference) in the Trademark Security Agreement (as defined below).

WHEREAS, the PI LLC, certain other Loan Parties and the Collateral Agent are party to that certain Term Loan Pledge and Security Agreement, dated as of July 22, 2020 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), pursuant to which PI LLC and certain other Grantors executed and delivered in favor of the Collateral Agent a Trademark Security Agreement, dated as of July 22, 2020, which was recorded in the United States Patent and Trademark Office on July 22, 2020 at Reel/Frame 7005/0610 (the "Trademark Security Agreement");

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, PI LLC and the other Grantors pledged, collaterally assigned, mortgaged, transferred and granted to the Collateral Agent, its successors and permitted assigns, on behalf of and for the ratable benefit of the Secured Parties, a continuing security interest (the "Security Interest") in the Trademark Collateral;

WHEREAS, the Trademark Collateral included all of PI LLC's right, title and interest in, to and under all of the following assets, whether then owned by or owing to, or thereafter acquired by or arising in favor of PI LLC: (i) all trademarks (including service marks), common law marks, trade names, trade dress, and logos, slogans and other indicia of origin under the laws of any jurisdiction in the world ("Trademarks"), and the registrations and applications for registration thereof and the goodwill of the business symbolized by the foregoing, including those registrations and applications in the United States Patent and Trademark Office listed on Schedule I hereto; (ii) all renewals of the foregoing; (iii) all income, royalties, damages, and payments now or hereafter due or payable with respect to the Trademarks, including, without limitation, damages, claims, and payments for past, present and future infringements and dilutions thereof; (iv) all rights to sue for past, present, and future infringements and dilutions thereof, including the right to settle suits involving claims and demands for royalties owing; and (v) all rights corresponding to any of the foregoing; in each case to the extent the foregoing items constitute Collateral (collectively, the "Released Trademark Collateral"), and PI LLC has requested that the Collateral Agent now terminate and release its Security Interest in the Released Trademark Collateral.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby releases, discharges, terminates and cancels the Security Interest in the Released Trademark Collateral arising under the Security Agreement and the Trademark Security Agreement, and hereby re-transfers, re-conveys and re-assigns to PI LLC any right, title and interest it has acquired in the Released Trademark Collateral under the Trademark Security Agreement, in each case without recourse to, or representation or warranty of any kind by, the Collateral Agent. For the avoidance of doubt, except as expressly set forth above, nothing herein shall affect the Security Interest held by the Collateral Agent in the Trademark Collateral, or any other security interest granted by PI LLC or any other Grantors to the Collateral Agent.

PI LLC, or any successor to PI LLC (including any person or entity hereafter having any right, title or interest in or to the Released Trademark Collateral), is hereby authorized to record this Release in the United States Patent and Trademark Office.

This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
