TERMINATION AND RELEASE OF SECURITY INTEREST IN SPECIFIED TRADEMARK RIGHTS

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN SPECIFIED TRADEMARK RIGHTS (this "<u>Termination and Release</u>"), dated as of December 18, 2020, by CRYSTAL FINANCIAL LLC, in its capacity as administrative agent for itself (in such capacity, the "<u>Administrative Agent</u>") and the other Secured Parties under the Term Loan Agreement (as defined below) to SOUTHERN STATES COOPERATIVE, INCORPORATED, a Virginia corporation ("<u>Southern States</u>").

WITNESSETH:

WHEREAS, reference is made to that certain Term Loan Agreement dated as of May 11, 2018, (as amended, supplemented, restated or otherwise modified from time to time, the "<u>Term Loan Agreement</u>"), by and among, among others, Southern States, the lenders from time to time party thereto and the Administrative Agent;

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of May 11, 2018 (the "2018 Trademark Security Agreement") and that certain Trademark Security Agreement dated as of October 9, 2020 (the "2020 Trademark Security Agreement" and together with the 2018 Trademark Security Agreement, the "Trademark Security Agreements"), a lien on and security interest (the "Security Interest") was granted by Southern States to the Administrative Agent, for the benefit of the Secured Parties, in certain collateral, including the trademark specified in Schedule 1 hereto (the "Specified Trademarks");

WHEREAS, the 2018 Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on May 22, 2018, at Reel/Frame 6330/0650;

WHEREAS, the 2020 Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on October 22, 2020, at Reel/Frame 7078/0094;

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Specified Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby agrees as follows:

- 1. <u>Definitions</u>. Capitalized terms not defined herein shall have the meanings set forth in the Trademark Security Agreements.
- 2. Release of Security Interest. The Administrative Agent, without representation, warranty or recourse, hereby terminates, releases and discharges any and all Security Interest in the Specified Trademarks, and any right, title or interest of the Administrative Agent in such Specified Trademarks shall hereby cease and become void. Notwithstanding the foregoing, (i) the Trademark Security Agreements are, and shall continue to be, in full force and effect, and (ii) except to the limited extent described in this Section 2, nothing in this Termination and Release extinguishes, novates or releases any right, claim, lien, security interest or entitlement of the Administrative Agent or the other Secured Parties created by or contained in the Trademark Security Agreements or in any other Loan Document nor is Southern States released from any covenant, warranty or obligation created by or contained therein.

3. <u>Recordation</u>. The Administrative Agent authorizes Southern States and its designees to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority at Southern States' expense.
