RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (the "Release") is made as of December 18, 2020, by UPPER90 CAPITAL MANAGEMENT, LP (f/k/a Upper90 Capital Management, LLC), as Administrative Agent (in such capacity, the "Administrative Agent"), in favor of the respective Grantors listed on Exhibit A hereto (the "Grantors").

WITNESSETH

WHEREAS, pursuant to (i) that certain Credit and Security Agreement, dated as of November 29, 2018 (the "Credit and Security Agreement"), by and among the Grantors, the other grantors party thereto and the Administrative Agent, and (ii) that certain Intellectual Property Security Agreement, dated as of August 6, 2019, by and among the Grantors and the Administrative Agent (the "Intellectual Property Security Agreement"; all capitalized terms used herein but not otherwise defined shall have the meanings set forth in the Intellectual Property Security Agreement), the Grantors granted the Administrative Agent a security interest in all of the Grantors' right, title and interest in, to and under the Trademarks (as that term is defined in the Intellectual Property Security Agreement) of the Grantors, including those trademarks identified on Schedule A attached hereto (the "IP Security Interest");

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on August 15, 2019 at Reel 6721, Frame 0584;

WHEREAS, the Grantors have satisfied in full the terms of the Credit and Security Agreement and Intellectual Property Security Agreement and requests a release of the IP Security Interest; and

WHEREAS, the Administrative Agent, on behalf of itself and the Secured Parties, desires to terminate and grant a release of the IP Security Interest as provided in this Release.

NOW THEREFORE, for good and valuable consideration previously tendered by the Grantors, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, on behalf of itself and the Secured Parties, does hereby agree as follows:

- 1. The Administrative Agent hereby (a) terminates the Intellectual Property Security Agreement, (b) releases, relinquishes, terminates and discharges the IP Security Interest in its entirety and (c) reassigns to the Grantors any and all right, title and interest of any nature whatsoever which it may hold in or to the any of the Trademarks (including, without limitation, the trademarks identified on Schedule A attached hereto) and associated common law rights and goodwill appurtenant thereto.
- 2. The Administrative Agent, on behalf of itself and the Secured Parties, authorizes the United States Patent and Trademark Office and any other applicable governmental authority to record this Release.
- 3. At the request and sole expense of the Grantors, the Administrative Agent, on behalf of itself and the Secured Parties, agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions necessary to carry out the purposes of this Release.
- 4. This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
