RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE dated as of December 17, 2020 (this “Release”) is made by THE NORTHERN TRUST COMPANY, an Illinois state chartered bank, (in such capacity, together with its successors and permitted assigns in such capacity, the “Lender”) of certain Trademark Security Interest, dated as of October 28, 1996 (as amended, supplemented or modified and in effect from time to time, the “Trademark Security Interest”) between RYTEC CORPORATION, an Illinois corporation (the “Borrower”) and the Lender. Capitalized terms used but not defined herein have the meanings provided in the Trademark Security Interest.


WHEREAS, pursuant to the Trademark Security Interest which was recorded at the United States Patent and Trademark Office (“USPTO”) on December 12, 1996 at Reel 1535 and Frame 0928, the Borrower granted to the Lender a continuing security interest in all of Grantor’s right, title and interest in, to and under the Trademark Collateral, including those set forth on the attached Schedule I.

WHEREAS, the Borrower has requested and the Lender has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the “Released Collateral”).

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Lender does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Interest in the Released Collateral, (b) release its security interest in the Released Collateral, (c) discharge any and all rights, title and interest it has in and the security interest granted to the Lender in the Released Collateral, and (d) reassigns, grants and conveys to the Grantor any and all right, title and interest it has in the Released Collateral.
