**RELEASE OF CONFIRMATORY GRANT OF
SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF CONFIRMATORY GRANT OF SECURITY INTEREST IN TRADEMARKS (the "**Release**") is effective as of the 21st day of December, 2020, by and between:

SUNRISE WINDOWS, LLC, a Delaware limited liability company, having an address of 200 Enterprise Drive Temperance, MI 48182 ("**Assignor**"), and

U.S. BANK NATIONAL ASSOCIATION, having an address of 800 Nicollet Mall, Minneapolis, Minnesota 55402 ("**Assignee**").

W I T N E S S E T H:

A. Assignor and Assignee, among others, entered into that certain Credit Agreement dated as of December 14, 2010, as amended by that certain Waiver and First Amendment to Credit Agreement dated as of December 31, 2011, Waiver and Second Amendment to Credit Agreement dated as of December 14, 2015, Forbearance Agreement and Third Amendment to Credit Agreement dated as of December 13, 2016, Waiver and Fourth Amendment to Credit Agreement dated as of January 31, 2017, Fifth Amendment to Credit Agreement dated as of July 27, 2018, Sixth Amendment to Credit Agreement dated as of November 25, 2019, and Seventh Amendment to Credit Agreement dated as of April 21, 2020 (as amended from time to time, the "**Credit Agreement**").

B. Assignor and Assignee, among others, are parties to the Pledge and Security Agreement and Irrevocable Proxy dated as of December 14, 2010, as supplemented by Joinder Agreement and Supplement to Security Agreement Schedules dated as of August 3, 2017 by PARAGON WINDOWS AND DOORS, LLC, a Delaware limited liability company and Sunrise Windows Holding Company, a Delaware corporation in favor of Agent (the "**Security Agreement**"), pursuant to which Assignor pledged, assigned and granted a security interest in favor of Assignee in certain Collateral (as defined therein).

C. Assignor and Assignee are parties to that certain Confirmatory Grant of Security Interest in United States Trademarks dated as of December 14, 2010, which was recorded with the United States Patent and Trademark Office ("**PTO**") on December 15, 2020, at Reel 4433, Frame 0823 (the "**Trademarks Assignment**").

D. Assignor has satisfied all of the Obligations under the Credit Agreement and the Security Agreement and requested that the Assignee terminate and release its security interests in and liens on the Collateral.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1) **Definitions.** All capitalized terms not defined in this Release shall have the respective meaning given to them in the Credit Agreement or the Security Agreement or the Trademarks Assignment, as the case may be.

2) **Termination and Release of Security Interest.** The Assignee hereby terminates, releases, and discharges its security interest in and liens on the Collateral, including, without limitation, the

Trademarks listed on Exhibit A hereto, and the Assignee hereby assigns and transfers to the Assignor, without representation, warranty or recourse, all of the Assignee's right, title and interest in and to such Trademarks, effective as of the date set forth above.

IN WITNESS WHEREOF, the Assignee has executed this Release effective as of the date written above.


