# RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

This RELEASE OF SECUITY INTEREST IN TRADEMARK RIGHTS ("Release") is made and effective as of December 17, 2020 and granted by TMI TRUST COMPANY (the "Collateral Agent"), a Florida corporation, as collateral agent for the secured parties under the Indenture referred to below (the "Secured Parties"), in favor of POPULUS FINANCIAL GROUP, INC. (formerly known as ACE Cash Express, Inc.), a Texas corporation (the "Grantor"), and its successors, assigns and legal representatives.

WHEREAS, pursuant to that certain Indenture dated as of December 15, 2017 (the "Indenture") among the Collateral Agent, the Grantor, the other Grantors (as defined therein) party thereto, the Grantor executed and delivered to the Collateral Agent (i) that certain Collateral Agreement by and among the Grantor, the Collateral Agent and other Grantors (as defined therein) party thereto dated as of December 15, 2017 (the "Collateral Agreement") and (ii) that certain Grant of Security Interest in Trademark Rights by and between the Grantor and the Collateral Agent dated as of December 15, 2017 (the "Trademark Agreement" and, together with the Collateral Agreement, the "Security Agreements");

WHEREAS, pursuant to the Security Agreements, the Grantor pledged and granted to the Collateral Agent for the ratable benefit of the Secured Parties a security interest in and to all of the right, title and interest of such Grantor in, to and under the IP Collateral (as defined below);

WHEREAS, the Trademark Agreement was recorded with the United States Patent and Trademark Office at Reel 6230, Frame 0436 on December 15, 2017; and

WHEREAS, the Grantor has requested that the Collateral Agent enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantor of any and all right, title and interest the Collateral Agent and the Secured Parties may have in the IP Collateral pursuant to the Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent hereby agrees as follows:

- 1. Release of Security Interest. Collateral Agent, on behalf of itself and the Secured Parties, their successors, legal representatives and assigns, hereby terminates the Trademark Agreement and terminates, releases and discharges any and all security interests that it has pursuant to the Security Agreements in any and all right, title and interest of the Grantor, and reassigns to the Grantor any and all right, title and interest that it may have, in, to and under the following (collectively, the "IP Collateral"):
  - (a) (i) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos and other indicators of the source of goods or services, and all goodwill associated therewith, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof or any other country or any political subdivision thereof, or otherwise, and all common-law rights related thereto and (ii) the right to obtain all renewals thereof ("Trademarks");

- (b) any agreement, whether written or oral, providing for the grant by or to any Grantor of any right to use any Trademark ("**Trademark Licenses**"),
- (c) all rights, priorities and privileges relating to the Trademarks and the Trademark Licenses, whether arising under United States, multinational or foreign laws or otherwise, including, without limitation, the Trademarks and the Trademark Licenses;
- (d) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and
- (e) any and all claims and causes of action with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.
- 2. <u>Further Assurances</u>. The Collateral Agent agrees, at the Grantor's expense, to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.
