**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

This Termination and Release of Trademark Security Agreement (this "Termination"), dated as of December 23, 2020, is executed by STERLING BUSINESS CREDIT, LLC (f/k/a NEWSTAR BUSINESS CREDIT, LLC) ("Secured Party"), and in favor of CRICUT, INC., a Delaware corporation, formerly known as Provo Craft & Novelty, Inc., a Utah corporation ("Grantor"). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreement (defined below).

RECITALS

A. Pursuant to that certain Trademark Security Agreement, dated as of January 7, 2016 (as amended, the "Security Agreement"), executed by Grantor in favor of Secured Party, Grantor granted to Secured Party a security interest in the Trademark Collateral (defined below).

B. The Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on January 11, 2016, at Reel 5706 and Frame 0101, to evidence the security interest granted under the Security Agreement.

C. Secured Party agrees to terminate and release its security interest in the Trademark Collateral specified below and to file this Termination with respect to such release of its security interest as herein provided.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby agrees as follows:

(a) Secured Party expressly terminates and releases all of Secured Party's right, title and interest in pursuant to the Security Agreement, to and under the following (collectively, the "Trademark Collateral"):

(i) all of its trademarks and trademark licenses to which it is a party including those referred to on Schedule I;

(ii) all goodwill of the business connected with the use of, and symbolized by, each trademark and each trademark license; and

(iii) all products and proceeds (as that term is defined in the UCC) of the foregoing, including any claim by Grantor against third parties for past, present or future (i) infringement or dilution of any trademark or any trademarks exclusively licensed under any trademark license, including right to receive any damages, (ii) injury to the goodwill associated with any trademark, or (iii) right to receive license fees, royalties, and other compensation under any trademark license.

(b) Secured Party represents and warrants that it has the full power and authority to execute this Termination.

(c) Secured Party authorizes and requests the Trademark Division of the United States Patent and Trademark Office to record this Termination.
