RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) is made as of December 29, 2020, by CORTLAND CAPITAL MARKET SERVICES LLC, as collateral agent for the Lenders and the other Secured Parties (in such capacity, together with its successors and permitted assigns, the “**Collateral Agent**”), in favor of COMMERCE TECHNOLOGIES, LLC (the “**Grantor**”). Capitalized terms used but not defined herein have the meanings specified (including by reference) in the Security Agreement (as defined below).

WHEREAS, the Grantor and the Collateral Agent are party to (i) that certain Second Lien Collateral Agreement dated as of May 21, 2018 (as amended, restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”) and (ii) that certain Second Lien Trademark Security Agreement, dated as of May 21, 2018 (the “**Trademark Security Agreement**”), whereby the Grantor granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in all of the Grantor’s right, title and interest in, to and under the Trademark Collateral (as defined in the Second Lien Trademark Security Agreement), including those United States Trademarks listed on Schedule I attached hereto;

WHEREAS, the Second Lien Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 22, 2018 at Reel/Frame 006362/0419; and

WHEREAS, the Grantor has requested that the Collateral Agent execute and deliver this Release to evidence the release of its security interest in the Trademark Collateral for filing and recordation with the United States Patent and Trademark Office.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, without any representation, warranty or recourse of any kind or nature, hereby releases and terminates its security interest in the Trademark Collateral, and re-assigns and re-conveys to the Grantor any and all right, title or interest the Collateral Agent may have in, to or under the Trademark Collateral.
