Re: Termination of Senior Credit Facility

Ladies and Gentlemen:

Reference is made to that certain senior credit facility (the "Credit Facility") evidenced by that certain Credit Agreement, dated as of June 29, 2018 (as amended, modified, extended, restated, replaced, or supplemented prior to the date hereof, the "Existing Credit Agreement"), among Rawlings Parent, Inc., a Delaware corporation (the "Company"), the lenders from time to time party thereto (the "Existing Lenders") and Bank of America, N.A., as administrative agent for the Existing Lenders (in such capacity, the "Existing Agent"), Swing Line Lender and L/C Issuer. Capitalized terms used herein without definition have the meanings given to them in the Existing Credit Agreement.

The Existing Agent understands that on December 31, 2020 (the "Payoff Date") the Company and the Subsidiary Guarantors (collectively, the "Loan Parties") intend to cause all indebtedness, liabilities and other Obligations of the Loan Parties under the Loan Documents, including, without limitation, all principal, accrued interest, costs, expenses and fees outstanding, including, without limitation, reasonable attorneys' fees, costs and expenses, to be repaid in full.

The total principal balance of the loans and advances made by the Existing Lenders to or for the benefit of the Loan Parties under the Existing Credit Agreement, together with all accrued but unpaid interest thereon, and the total amount of all fees, costs, expenses and other amounts owed by the Loan Parties with respect to the Credit Facility under the Existing Credit Agreement and all other Loan Documents, if paid on the Payoff Date by 3:00 p.m. (Eastern Time) (the "Payoff Time"), will be as follows (the "Payoff Amount"):

Legal Fees/Expenses of Outside Counsel ( <u>Legal Fees</u> ):	\$11,000.00

If payment of the Payoff Amount is not made by the Payoff Time on the Payoff Date, the Payoff Amount will be recalculated to include (i) for the Payoff Date itself, an additional \$36,252.28 and (ii) for each day thereafter, an additional \$36,350.08 per day, in each case, in accordance with the provisions of the Existing Credit Agreement (the "Per Diem Amount"); provided that the Existing Agent receives the Payoff Amount together with all applicable Per Diem Amounts no later than 3:00 p.m. (Eastern Time) on January 5, 2021

(the “Expiration Time”) after which time this letter agreement shall have no further force or effect. The Loan Parties hereby agree not to request additional Loans or Letters of Credit under the Existing Credit Agreement on or after the date hereof through the Expiration Time.

The Existing Agent hereby instructs the Loan Parties to pay or cause to be paid the Payoff Amount (other than the Legal Fees) by wire transfer, in immediately available funds, to the following account in accordance with the following wire transfer instructions:

Subject to (a) the receipt by the Existing Agent of the Payoff Amount (net of the Legal Fees) and any applicable Per Diem Amount and receipt by McGuireWoods LLP of the Legal Fees, and (b) the receipt by the Existing Agent of a fully executed copy of this Payoff Letter, duly executed by the Company (collectively, the “Payoff Items”), the Existing Agent (on behalf of itself and the Existing Lenders) agrees that (I) all Obligations of the Loan Parties under the Loan Documents (other than (i) obligations under the Loan Documents (including contingent reimbursement obligations and indemnity obligations) which, by their express terms, survive termination of the Existing Credit Agreement or such other Loan Document, as the case may be, and (ii) to the extent not paid on the Payoff Date, fees and expenses of counsel to the Existing Agent in connection with the termination of the Loan Documents and release of all liens thereunder), including principal, accrued interest, costs, expenses and fees, shall be paid in full, released and discharged, (II) all Loan Documents (including Letters of Credit) shall be terminated and of no further force and effect, (III) all commitments of the Existing Lenders shall be terminated, (IV) all guarantees provided under the Loan Documents shall be terminated and of no further force and effect, (V) any security interest or Lien granted to the Existing Lenders and/or the Existing Agent in any assets of the Loan Parties securing the Obligations shall automatically terminate and be released without further action by any Person, (VI) upon the Existing Agent’s or its’ counsel, McGuireWoods LLP’s, written confirmation (which may be via e-mail) to the Company (or its designees, including legal counsel) of the Existing Agent’s receipt of the Payoff Items, the Existing Agent’s signature pages to the releases of security interest in intellectual property attached hereto as Exhibit B (the “IP Releases”) shall be released from escrow and (VII) upon the Existing Agent’s or its’ counsel, McGuireWoods LLP’s, written confirmation (which may be via e-mail) to the Company (or its designees, including legal counsel) of the Existing Agent’s receipt of the Payoff Items, the Company (and its designees, including legal counsel), are authorized to file with appropriate filing offices (i) solely the UCC-3 termination statements in the forms attached hereto as Exhibit A, and (ii) the IP Releases (and the Company agrees to deliver filed copies of such UCC-3 termination statements and IP Releases to the Existing Agent reasonably promptly after receipt thereof).

At the expense of the Company (it being understood and agreed that such expense may be in

addition to the amounts included in the Payoff Amount), the Existing Agent will promptly upon receipt of each of the Payoff Items, (a) execute, as applicable, and deliver to the Company (or any designee of the Company) any further lien releases, mortgage releases, discharges of security interests, pledges and guarantees and other similar discharge or release documents, as are reasonably requested and necessary from time to time to release the security interests and all notices of security interests and liens previously filed by the Existing Agent under the Loan Documents and (b) deliver to the Company (or any designee of the Company) all instruments evidencing pledged debt and all equity certificates and any other similar collateral previously delivered in physical form by the Loan Parties to the Existing Agent under the Loan Documents.

Notwithstanding the terms of this letter agreement to the contrary, (a) upon any Existing Lender's demand, without duplication of any Breakage Costs included in the Payoff Amount or applicable Per Diem Amount, the Company shall promptly compensate such Existing Lender for any breakage costs incurred in connection with the payment of the Payoff Amount and any applicable Per Diem Amount in accordance with the terms of Section 3.05 of the Existing Credit Agreement, and (b) if the Existing Agent determines after the Payoff Time that an amount that was due and payable under the Loan Documents was mistakenly excluded from the Payoff Amount, the Company agrees to promptly pay such excluded amount after the Existing Agent provides evidence to the Company that such excluded amount is due and payable. The provisions of this paragraph shall remain in full force and effect regardless of any termination of the obligations owing under the Loan Documents.

As of the Payoff Date, the Loan Parties hereby irrevocably terminate any commitment under the Loan Documents to lend or make advances by the Existing Agent or any Existing Lender (including the issuance of any new Letter of Credit or the renewal or extension of any outstanding Letter of Credit by the L/C Issuer).

It is acknowledged and agreed that this document constitutes a "Loan Document" for purposes of Sections 10.04, 10.14 and 10.15 of the Existing Credit Agreement.
