RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of January 25, 2021 (the “Effective Date”), is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, as Notes Collateral Agent (in such capacity, the “Agent”), in favor of INTERACTIVE ONE, INC. (the “Grantor”). All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed to them in the Trademark Security Agreement (whether defined therein or by reference to another agreement).

WHEREAS, pursuant to that certain Security Agreement, dated as of November 9, 2020, among the Grantor, the other grantors party thereto, and the Agent (as may have been amended, modified, restated, and/or supplemented from time to time, the “Security Agreement”), the Grantor executed and delivered a Grant of Security Interest in United States Trademarks, dated as of November 9, 2020 (the “Trademark Security Agreement”), which was recorded with the United States Patent and Trademark Office (“USPTO”) on November 9, 2020 at Reel/Frame 7099/0087;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, the Grantor granted to the Agent a continuing security interest (the “Security Interest”) in all of the following that constituted Collateral: (i) all of the Grantor’s right, title and interest in, to and under to the United States trademarks, service marks, trade names, trade dress, logos, designs, fictitious business names and other business identifiers, and the registrations and applications for registrations thereof set forth on Schedule A attached hereto (the “Marks”), (ii) all Proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement or dilution of any of the Marks or unfair competition regarding the same (the “Trademark Collateral”); and

WHEREAS, the Agent and the Grantor acknowledge that the requirements for releasing the Security Interest in the Trademark Collateral have been met.


NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, hereby (i) terminates and cancels the Trademark Security Agreement, (ii) releases, discharges, terminates and cancels the Security Interest in and to the Trademark Collateral, and (iii) retransfers and reassigns to the Grantor any right, title or interest the Agent may have in, to or under the Trademark Collateral, in each case without recourse to the Agent and without representation or warranty of any kind.

The Grantor, or any successor to the Grantor (including any person or entity hereafter having any right, title or interest in or to the Trademark Collateral), is hereby authorized to record this Release in the USPTO.
