This TERMINATION AND RELEASE dated as of January 27, 2021, from GEOFFREY, LLC, a Delaware limited liability company ("Geoffrey"), (the "Geoffrey Debtor") and ("the "Transferors"), and TRU KIDS INC., a Delaware Corporation (the "Company").

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of October 16, 2017 (the "Security Agreement"), Geoffrey, LLC has executed that certain Trademark Security Agreement, effective as of October 16, 2017, and recorded in the United States Patent and Trademark Office at Trademark Reel 006186 Frame 0381 (the "Trademark Security Agreement");

WHEREAS, pursuant to the Trademark Security Agreement, a security interest (the "Security Interest") was granted by Geoffrey, LLC in favor of NexBank, SSB as administrative agent, in, to and under certain collateral, as defined in the Trademark Security Agreement, including without limitation the trademarks identified on Schedule A hereto (collectively, the "Collateral");

WHEREAS, on September 18, 2017, Geoffrey, together with certain of its subsidiaries and affiliates, filed voluntary petitions for relief, Case No. 17-34665 (Jointly Administered) (the "Bankruptcy Case") under Chapter 11 of the United States Bankruptcy Code (the "Bankruptcy Code") in the United States Bankruptcy Court for the Eastern District of Virginia (the "Court");

WHEREAS, on November 21, 2018, the Court entered its Order Confirming the Fourth Amended Chapter 11 Plans of the Toys Delaware Debtors and Geoffrey Debtors [Docket No. 5746] (the "Confirmation Order"), confirming that certain Fourth Amended Joint Chapter 11 Plans of the Toys Delaware Debtors and the Geoffrey Debtors [Docket No. 5602] as may be amended, modified, and supplemented from time to time (the "Plan"; capitalized terms used herein and not otherwise defined shall have the meanings ascribed to them in the Plan);

WHEREAS, the Effective Date of the Plan occurred on January 20, 2019;

WHEREAS, pursuant to the Plan, the Transferors and the Company entered into that certain Asset Transfer Agreement as of January 20, 2019 (the "<u>Agreement</u>") whereby the Transferors transferred, conveyed, assigned and delivered to the Company (or a direct or indirect subsidiary of the Company) all of such Transferors' right, title and interest in and to the assets of the Transferors set forth on <u>Schedule 1</u> to the Agreement, including the Transferred Intellectual Property (as defined in the Agreement) (collectively, the "<u>Transferred Assets</u>");

WHEREAS, the Transferred Assets constitute Collateral under the Security Agreement and the Trademark Security Agreement;

WHEREAS, pursuant to paragraph 82 of the Confirmation Order, on the Effective Date of the Plan, the Transferred Assets and Collateral (as property and assets of the Estates of the Transferors) automatically, without further notice to or order of the Court, act or action under

applicable law, regulation, order, rule, or any requirement of further action, vote, or other approval or authorization of the security holders, equity owners, members, managers, officers, or directors of the Debtors or by any other person, vested in the Transferors free and clear of all Claims, Liens, charges, and other encumbrances;

WHEREAS, pursuant to paragraphs 50 and 128 of the Confirmation Order, on the Effective Date, all mortgages, deeds of trust, Liens, pledges, or other security interests against the Transferred Assets and Collateral, including the Security Interest, were fully released, settled, and compromised and all rights, titles, and interests of any Holder of such mortgages, deeds of trust, Liens, pledges, or other security interests against any of the Transferred Assets and Collateral reverted to the Transferors, as set forth in Article VIII.B of the Plan;

WHEREAS, pursuant to paragraph 98 of the Confirmation Order, the Transferors and the Company, and their respective directors, officers, members, agents, and attorneys, financial advisors, and investment bankers are authorized and empowered from and after the date of the Confirmation Order to negotiate, execute, issue, deliver, implement, file, or record any contract, instrument, release, or other agreement or document related to the Plan, as the same may be modified, amended and supplemented, and to take any action necessary or appropriate to implement, effectuate, consummate, or further evidence the Plan in accordance with its terms and the terms of the Confirmation Order, whether or not specifically referred to in the Plan or any exhibit thereto, without further order of the Bankruptcy Court;

WHEREAS, the Security Interest in the Transferred Assets and Collateral having been fully released, settled, and compromised pursuant to the Confirmation Order and Plan, the Transferors and the Company, as authorized and empowered under the Confirmation Order, hereby file this termination and release of the Trademark Security Agreement recorded in the United States Patent and Trademark Office at Trademark Reel 006186 Frame 0381.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Collateral (including the Transferred Assets) pursuant to the Confirmation Order and Plan, and the Security Interest in and any and all claims against the Collateral (including the Transferred Assets) having been terminated, released and discharged under the Confirmation Order and Plan, all rights, titles and interests in and against such Collateral pursuant to the Security Agreement and the Trademark Security Agreement recorded at Trademark Reel 006186 Frame 0381, have ceased and become void and of no further force or effect.
