**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This Release of Security Interest in Trademark Collateral is made and effective as of February 2, 2021 (“Release of Security Interest”) by Cortland Capital Market Services LLC, solely in its capacity as collateral agent (as successor to JPMorgan Chase Bank, N.A.) (in such capacity, the “Collateral Agent”) for the Secured Parties (as defined in the Credit Agreement (as defined below)).

WHEREAS, reference is hereby made to that certain Term Loan Credit Agreement dated as of June 30, 2015 (as amended, modified or amended and restated prior to the date hereof, the “Credit Agreement”) by and among Horizon Global Corporation (“Borrower”), the financial institutions party thereto from time to time as lenders (collectively, the “Lenders”), Collateral Agent and Cortland Capital Market Services LLC (as successor to JPMorgan Chase Bank, N.A.) as administrative agent for the Lenders. Unless otherwise indicated, all capitalized terms used herein and not otherwise defined herein shall have the respective meanings provided such terms in the Credit Agreement or the Guarantee and Collateral Agreement (as defined below).

WHEREAS, pursuant to the Credit Agreement, the Borrower and certain other Grantors (as defined in the Guarantee and Collateral Agreement (as defined below)) executed that certain Guarantee and Collateral Agreement dated as of June 30, 2015 (the “Guarantee and Collateral Agreement”), whereby the Borrower and such Grantors granted the Collateral Agent a security interest in all Borrower’s and such Grantors’ right, title and interest in Intellectual Property, including the Trademarks, and including certain United States trademark registrations and trademark applications and certain Canadian trademark registrations and trademark applications as set forth on Schedule A attached hereto (collectively, the “Trademark Collateral”).

WHEREAS, in connection with the Guarantee and Collateral Agreement, the Grantors (as applicable) executed the Grants of Security Interest in Trademark Rights detailed in Schedule A hereof (the “Grant of Security Interest in Trademark Rights”) in favor of Collateral Agent, which were recorded with the United States Patent and Trademark Office and the Canadian Intellectual Property Office, as applicable, as detailed on Schedule A hereof.

WHEREAS, pursuant to the Payoff Letter, dated as of February 2, 2021, by and among the Borrower, the other Loan Parties, the Lenders, the Administrative Agent and the Collateral Agent, the Grantors have request and the Collateral Agent has agreed to release its security interest in all of the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby states as follows:

1. Release of Security Interest. The Collateral Agent, without recourse, representations and warranties of any kind, hereby terminates, discharges, cancels


and releases all of its security interests in and liens on all of the Trademark Collateral granted under the Guarantee and Collateral Agreement and the Grants of Security Interest in Trademark Rights and any other Loan Documents, and reassigns to the Borrower and the Grantors any and all right, title and interest that it may have in and to the Trademark Collateral, and the Collateral Agent hereby acknowledges and agrees that it has no further right, title or interest in, to or under the Trademark Collateral, and that the Grants of Security Interest in Trademark Rights are terminated and of no further force and effect.

2. Governing Law. This Release of Security Interest and the transactions contemplated hereby, and all disputes between the parties under or relating to this Release of Security Interest or the facts or circumstances leading to its execution, whether in contract, tort or otherwise, shall be construed in accordance with and governed by the laws (including statutes of limitation) of the State of New York, without regard to conflicts of law principles that would require the application of the laws of another jurisdiction.
3. Further Assurances. The Collateral Agent hereby authorizes the Borrower and the Grantors, and any of their designees, to file this Release of Security Interest and other necessary filings with the United States Patent and Trademark Office and the Canadian Intellectual Property Office, as applicable, and agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be necessary to effectuate the release of the Security Interest contemplated hereby, each at the Borrower's and the other Grantors' sole cost and expense.
