INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (this “IP Assignment Agreement”), is made as of January 5, 2021, by and among Meredith Corporation, an Iowa corporation (“Meredith Corporation”), TI Gotham Inc., a Delaware corporation (“TI Gotham Inc.”), TI Inc. Affluent Media Group, a New York corporation (“Affluent Media” and together with Meredith Corporation and TI Gotham Inc., the “Sellers” and each, a “Seller”) and Travel + Leisure Holdco, LLC, a Delaware limited liability company (“Buyer”). The Sellers and the Buyer shall be referred to herein from time to time as the “Parties” and each, a “Party.” Capitalized terms used but not defined in this IP Assignment Agreement shall have the meanings set forth in the Asset Purchase Agreement (as defined below).

WHEREAS, pursuant to that certain Asset Purchase Agreement, dated as of the date hereof, by and among Sellers, Buyer and Wyndham Destinations, Inc., a Delaware corporation (the “Asset Purchase Agreement”), the Sellers have agreed to transfer, assign, and deliver to the Buyer the Acquired Assets and the Buyer has agreed to purchase and acquire the Acquired Assets, all in accordance with the terms set forth in the Asset Purchase Agreement; and

WHEREAS, pursuant to the Asset Purchase Agreement, *inter alia*, the Sellers have agreed to assign to the Buyer and the Buyer has agreed to acquire from the Sellers, those certain domain names, trademarks, and copyrights set forth therein (such domain names, trademarks, and copyrights constituting a part of the Acquired Assets) (as also listed on Exhibit A, Exhibit B, and Exhibit C hereto) as of the Closing (as defined in the Asset Purchase Agreement).

NOW, THEREFORE, in consideration of the premises and mutual promises contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the Parties hereby agree as follows:

1. Assignment. Each Seller, as applicable, hereby irrevocably assigns, transfers and conveys to the Buyer all rights, title and interest in the following, in each case, free and clear of all Liens, except for Permitted Liens (in each case, as defined in the Asset Purchase Agreement):

a. the Internet domain names listed on Exhibit A hereto (the “Assigned Domain Names”);

b. the Trademarks listed on Exhibit B hereto (the “Assigned Trademarks”), together with the goodwill associated therewith; and

c. the Copyrights listed on Exhibit C (the “Assigned Copyrights,” and, together with the Assigned Domain Names and Assigned Trademarks, the “Assigned IP”).

2. Recordation and Further Actions.

a. Each Seller, as applicable, hereby authorizes and requests the Commissioner for Trademarks in the United States Patent and Trademark Office and the Register of Copyrights in the United States Copyright Office, and the officials of corresponding entities or agencies in any applicable jurisdictions throughout the world to record and register this IP Assignment Agreement upon request by the Buyer.

b. Following the Closing, upon the Buyer's request, each Seller, as applicable, will take such steps and actions, and provide such cooperation and assistance to the Buyer and its successors, assigns, and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents as may be reasonably necessary to effect, evidence, or perfect the assignment of the Assigned IP to the Buyer, or any assignee or successor thereto. Further, Sellers and their successors and assigns shall testify in any legal proceedings, sign all lawful papers, make all lawful oaths and generally do everything possible reasonably requested by Buyer to vest title to the Assigned IP in Buyer and to aid Buyer, its successors, assigns and legal representatives to obtain and enforce proper protection for the Assigned IP. The transfer and assignment of the Assigned Domain Names shall be deemed to have been perfected for purposes of the preceding sentence when: (i) the Buyer's registrar has confirmed the transfer; (ii) the applicable WHOIS database identifies the Buyer or the Buyer's representative as the registrant of the Assigned Domain Names; and (iii) the Buyer has administrative and technical access to the Assigned Domain Names and sole control over the locations to which the Assigned Domain Names refer visitors.

3. Further Assurances. Each Seller agrees to: (a) cooperate with Buyer in taking any action which Buyer reasonably requests to perfect or enforce Buyer's rights hereunder, and (b) execute, when requested, any other documents reasonably requested by Buyer in connection therewith.

4. Terms of the Asset Purchase Agreement. This IP Assignment Agreement is intended to evidence the consummation of the transfer and assignment by the Sellers to the Buyer of the Assigned IP, as contemplated by the Asset Purchase Agreement and pursuant to the terms thereof which are hereby incorporated by reference into this IP Assignment Agreement. Each Seller and the Buyer, by their execution of this IP Assignment Agreement, each hereby acknowledges and agrees that neither the representations and warranties nor the rights and remedies of any Party under the Asset Purchase Agreement shall be deemed to be enlarged, modified, or altered in any way by this IP Assignment Agreement. In the event of any inconsistencies or ambiguities between this IP Assignment Agreement and the Asset Purchase Agreement, the terms of the Asset Purchase Agreement shall govern.

5. Miscellaneous. This IP Assignment Agreement shall inure to the benefit of the Parties and their respective successors and assigns, and shall be binding upon and enforceable against the Parties and their respective successors and assigns. This IP Assignment Agreement shall be governed by and construed in accordance with the laws of the State of Delaware, without giving effect to any choice of law or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction) that would cause the application of the law of any jurisdiction other than the State of Delaware. Neither Buyer nor Sellers intend that this IP Assignment Agreement shall benefit or be enforceable by any Person other than Buyer and Sellers and their respective successors and permitted assigns.

6. Counterparts. This IP Assignment Agreement may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this IP Assignment Agreement by facsimile or scanned page (including .PDF) shall be as effective as delivery of a manually executed counterpart to this IP Assignment Agreement.




