**TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Termination and Release of Intellectual Property Security Agreement (this "Termination"), dated as of February 3<sup>rd</sup>, 2021, is executed by SILICON VALLEY BANK, a California corporation ("Bank"), in favor of ZOCDOC, INC., a Delaware corporation ("Grantor"). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Security Agreements (defined below).

**RECITALS**

A. Pursuant to that certain Intellectual Property Security Agreement, dated as of March 26, 2015 ("Security Agreement", as supplemented by that certain First Supplement to Intellectual Property Security Agreement, dated as of June 30, 2016 ("First Supplement"), as supplemented by that certain Second Supplement to Intellectual Property Security Agreement, dated as of March 27, 2017 ("Second Supplement"), as supplemented by that certain Third Supplement to Intellectual Property Security Agreement, dated as of March 18, 2019 ("Third Supplement"), as supplemented by that certain Fourth Supplement to Intellectual Property Security Agreement, dated as of March 18, 2020 ("Fourth Supplement", and together with Security Agreement, First Supplement, Second Supplement, and Third Supplement, the "Security Agreements"), executed by Grantor in favor of Bank, Grantor granted to Bank a security interest in the IP Collateral (defined below).

B. The Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on April 13, 2015 at Reel/Frame 035412/0001, the Second Supplement was recorded on March 28, 2017 at Reel/Frame 042107/0538, the Third Supplement was recorded on March 18, 2019 at Reel/Frame 048921/0804, and the Fourth Supplement was recorded on March 19, 2020 at Reel/Frame 052169/0668, to evidence the security interest granted under the Security Agreements.

C. The Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on March 27, 2015 at Reel/Frame 5486/0534, the First Supplement was recorded on July 6, 2016 at Reel/Frame 5829/0474, the Third Supplement was recorded on March 18, 2019 at Reel/Frame 6593/0904, and the Fourth Supplement was recorded on March 19, 2020 at Reel/Frame 6895/0908, to evidence the security interest granted under the Security Agreements.

D. Bank agrees to terminate and release its security interest in the IP Collateral specified below and to file this Termination with respect to such release of its security interest as herein provided.

**AGREEMENT**

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Bank hereby agrees as follows:

(a) Bank expressly terminates and releases all of Bank's right, title and interest in pursuant to the Security Agreements, to and under the following (collectively, the "IP Collateral"):

(i) Any and all copyright rights, copyright applications, copyright registrations and like protections in each work of authorship and derivative work thereof, whether published or unpublished and whether or not the same also constitutes a trade secret, now or hereafter existing, created, acquired or held, including without limitation those set forth on Exhibit A attached hereto (collectively, the "Copyrights");

(ii) Any and all trade secrets, and any and all intellectual property rights in computer software and computer software products now or hereafter existing, created, acquired or held;

(iii) Any and all design rights that may be available to Grantor now or hereafter existing, created, acquired or held;

(iv) All patents, patent applications and like protections including, without limitation, improvements, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same, including without limitation the patents and patent applications set forth on Exhibit B attached hereto (collectively, the "Patents");

(v) Any trademark and servicemark rights, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of Grantor connected with and symbolized by such trademarks, including without limitation those set forth on Exhibit C attached hereto (collectively, the "Trademarks");

(vi) All mask works or similar rights available for the protection of semiconductor chips, now owned or hereafter acquired, including, without limitation those set forth on Exhibit D attached hereto (collectively, the "Mask Works");

(vii) Any and all claims for damages by way of past, present and future infringements of any of the rights included above, with the right, but no the obligation, to, upon the occurrence and during the continuance of an Event of Default, sue for and collect such damages for said use or infringement of the intellectual property rights identified above;

(viii) All licenses or other rights to use any of the Copyrights, Patents, Trademarks, or Mask Works and all license fees and royalties arising from such use to the extent permitted by such license or rights;

(ix) All amendments, extensions, renewals and extensions of any of the Copyrights, Trademarks, Patents, or Mask Works; and

(x) All proceeds and products of the foregoing, including without limitation all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing.

(b) Bank represents and warrants that it has the full power and authority to execute this Termination.

(c) Bank authorizes and requests the Trademark and Patent Divisions of the United States Patent and Trademark Office and the United States Copyright Office to record this Termination.
