SUPPLEMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENTS

This Supplement to Intellectual Property Security Agreements (this "Supplement") is made as of April 29, 2020 by and among (i) SILICON VALLEY BANK ("Agent") and (ii) ATRICURE, INC., a Delaware corporation with its chief executive office located at 7555 Innovation Way, Mason, Ohio 45040 ("Atricure"), (iii) ATRICURE, LLC, a Delaware limited liability company ("Atricure LLC"), (iv) ENDOSCOPIC TECHNOLOGIES, LLC, a Delaware limited liability company ("Endoscopic"), (v) nCONTACT SURGICAL, LLC, a Delaware limited liability company ("nContact"), and (vi) SENTREHEART, LLC a Delaware limited liability company, successor by merger with SentreHEART, Inc. ("SentreHEART" and, together with Atricure, Atricure LLC and Endoscopic, individually and collectively, jointly and severally, the "Grantor").

WHEREAS, Atricure, Atricure LLC, Endoscopic and nContact executed and delivered an Intellectual Property Security Agreement dated February 23, 2018 (as amended of record and supplemented from time to time hereinafter, the "Joint IP Agreement") in favor of the Agent, pursuant to which Atricure, Atricure LLC, Endoscopic and nContact collectively pledged, assigned and granted a security interest in certain Intellectual Property Collateral, which was submitted to the U.S. Patent and Trademark Office for recording on December 18, 2018 and thereafter supplemented by that certain Supplement to Intellectual Property Security Agreement dated as of December 28, 2018.

WHEREAS, SentreHEART executed and delivered an Intellectual Property Security Agreement dated December 27, 2019 (as amended of record and supplemented from time to time hereinafter, the "SentreHEART IP Agreement" and, together with the Joint IP Agreement, the "IP Agreements") in favor of the Agent, pursuant to which SentreHEART pledged, assigned and granted a security interest in certain Intellectual Property Collateral.

WHEREAS, the Grantor has developed additional patents and additional trademarks, and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional patents and trademarks in favor of Agent.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

- 1. <u>Definitions</u>. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the IP Agreements.
- 2. Supplements to Exhibit B.
 - a. <u>Exhibit B</u> to the Joint IP Agreement is hereby supplemented, but not replaced, by Exhibit B-1 annexed hereto.
 - b. <u>Exhibit B</u> to the SentreHEART IP Agreement is hereby supplemented, but not replaced, by Exhibit B-2 annexed hereto.
- 3. <u>Supplements to Exhibit C. Exhibit C</u> to the Joint IP Agreement is hereby supplemented, but not replaced, by Exhibit C annexed hereto.

4. <u>Miscellaneous</u>:

- a. Except as provided herein, all terms and conditions of the IP Agreements remain in full force and effect. The Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.
- b. This Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
