Pursuant to Sections 14-2-1109.1 and 14-11-212 of the Official Code of Georgia Annotated ("O.C.G.A."), the undersigned, being the Attorney-in-Fact of W.C. Bradley/Zebco Holdings, Inc., a Georgia corporation (the "Corporation"), does hereby certify as follows:

1. The name of the Corporation making the election to become a limited liability company is W. C. Bradley/Zebco Holdings, Inc., a Georgia corporation.

2. The Corporation elects to become a Georgia limited liability company (the "Company") pursuant to Sections 14-2-1109.1 and 14-11-212 of the O.C.G.A. The name of such Georgia limited liability company shall be W. C. Bradley/Zebco Holdings, LLC.

3. The election to become a Georgia limited liability company (the "Election") shall become effective at the time of filing this Certificate with the Georgia Secretary of State (the "Effective Time").

4. The Plan of Conversion of the Corporation to convert the Corporation from a Georgia corporation to a Georgia limited liability company has been approved by the board of directors of the Corporation and the sole shareholder of the Corporation (the "Sole Shareholder") as required by Sections 14-2-1109.1 and 14-11-212 of the O.C.G.A.

5. Filed with this Certificate of Conversion are Articles of Organization in the form required by Section 14-11-204 of the O.C.G.A., that set forth a name for the Company that satisfies the requirements of Section 14-11-207 of the O.C.G.A., and that shall be the Articles of Organization of the Company formed pursuant to this election unless or until modified in accordance with the O.C.G.A.

6. All of the outstanding shares of the Corporation, which are held by the Sole Shareholder, will be converted into a one hundred percent (100%) membership interest of the Company by reason of the Conversion.
