RELEASE OF SECURITY INTEREST

This Release of Security Interest (this "Release") is made as of February 1, 2021, by COMERICA BANK, a Texas banking association ("Lender") in favor of TWO SIX LABS HOLDINGS, INC., a Delaware corporation ("Company") with its principal place of business located at 4350 N. Fairfax Drive, Suite 410, Arlington, VA 22203. Capitalized terms not otherwise defined in this Release shall have the meanings provided or provided by reference in the IP Security Agreement (as defined below).

Recitals

WHEREAS, Lender and the Company entered into that certain Loan and Security Agreement dated as of January 22, 2018 (as amended, restated, replaced and supplemented from time to time, the "Security Agreement"), pursuant to which Lender required Company to execute that certain Intellectual Property Security Agreement (Two Six Labs Holdings, Inc.) dated as of January 22, 2018 (the "IP Security Agreement"), which was recorded with the US Patent and Trademark Office ("USPTO") on January 29, 2018 at Reel and Frame Number 6259/0528, and again on January 31, 2020 at Reel and Frame Number 6852/0880.

WHEREAS, pursuant to the IP Security Agreement, to secure the prompt and complete payment and performance when due of the Secured Obligations then existing or thereafter arising, the Company granted and pledged to Lender a security interest (the "Security Interest") in all of the Company's right, title and interest in, to and under its Intellectual Property Collateral, including the Trademarks listed on Exhibit A, and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof.

WHEREAS, Company has no outstanding obligations to Lender under the terms of the Security Agreement, Lender wishes to discharge, cancel, terminate and release the Security Interest in the Intellectual Property Collateral.

Agreement

NOW, THEREFORE, Lender agrees that it hereby discharges, cancels, terminates and releases the Security Interest in the Intellectual Property Collateral and reassigns to Company, without warranty or recourse, all interest of Lender in the Intellectual Property Collateral. The Company (and any successor to the Company, including any person or entity hereafter holding any right, title or interest in and to the Intellectual Property Collateral), is hereby authorized to record this Release with the USPTO.



