## **CONFIRMATORY ASSIGNMENT**

**WHEREAS**, Max Rohr, Inc. (hereinafter “Assignor”) is the owner of all right, title and interest in and to the trademarks and the associated U.S. registrations identified in the attached Exhibit A which is, by this reference, expressly incorporated herein (collectively the “Rohr Trademarks”), together with the goodwill of the business in the U.S. symbolized thereby;

**WHEREAS**, the Rohr Trademarks together with the goodwill of the business in the U.S. symbolized thereby were transferred from Assignor to AUSA Premium Cigar Holdings Inc. (hereinafter “Assignee”) as part of a series of simultaneous transactions, namely: (i) a transfer from Assignor to ITG Cigars Inc. pursuant to a Sale Agreement dated 9/21/2020; and (ii) a transfer from ITG Cigars Inc. to Assignee pursuant to a Sale and Transfer Agreement dated 9/21/2020;

**WHEREAS**, in order to memorialize the transfer of the Rohr Trademarks together with the goodwill of the business in the U.S. symbolized thereby from Assignor to Assignee, Assignor has agreed to execute this Confirmatory Assignment;

**NOW, THEREFORE**, for One Dollar and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor hereby confirms the sale, assignment, transfer and conveyance unto Assignee, effective as of 9/21/2020, of all of its right, title and interest in and to the Rohr Trademarks, together with the goodwill of the business in the U.S. symbolized thereby.

2. Assignor hereby further confirms the assignment unto Assignee of all of its right to sue for and to receive all damages accruing from past, present and future infringement of the Rohr Trademarks.

3. Assignor agrees that, upon the reasonable request of Assignee, Assignor will execute any and all papers or instruments that in the reasonable opinion of the Assignee may be

necessary or desirable to secure to said Assignee the full enjoyment of the rights, title and interest the conveyance of which is hereby confirmed.

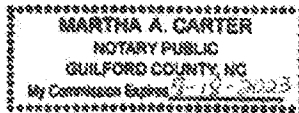
