This Termination and Release of Patent and Trademark Security Agreement (this "Patent and Trademark Release") is made as of December 23, 2020, by JPMORGAN CHASE BANK, N.A. in its capacity as administrative agent (the "Administrative Agent"), for the Lenders and the other Secured Parties (as defined in the Patent and Trademark Security Agreement referred to below) and the Borrowers listed on Schedule A attached hereto, (each a "Grantor" and collectively, the "Grantors").

WHEREAS, pursuant to that certain Patent and Trademark Security Agreement, dated as of January 3, 2011, by and among the Grantors and the Administrative Agent (as amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date thereof, the "Patent and Trademark Security Agreement"; capitalized terms used herein but not defined herein shall have the meanings ascribed to such terms in the Patent and Trademark Security Agreement), each of the Grantors unconditionally granted, assigned, and pledged to the Administrative Agent (for the benefit of the Lenders and the other Secured Parties) a continuing security interest (the "Security Interest") in all of such Grantor's right, title and interest in and to the Patent and Trademark Collateral;

WHEREAS, the Patent and Trademark Security Agreement was recorded with the United States Patent and Trademark Office on March 21, 2011 at Reel 004502, Frame 0067 for the Trademark Collateral listed on Schedule II attached hereto; and

WHEREAS, the Grantors have requested that the Administrative Agent execute this Patent and Trademark Release in order to terminate and release the Administrative Agent's Security Interest in the Patent and Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged:

- 1. Release of Lien. The Administrative Agent hereby terminates the Patent and Trademark Security Agreement and hereby terminates, cancels and releases the Security Interest and all other liens and security interests that it has in, to and under the Patent and Trademark Collateral, including, without limitation, (a) those Patent registrations and applications referred to on Schedule I attached hereto and all reissues, continuations, divisions, continuations-in-part, renewals or extensions thereof, and (b) all Trademark registrations and applications referred to on Schedule II attached hereto and all extensions or renewals thereof, all goodwill associated therewith or symbolized thereby, all other assets, rights and interests that uniquely reflect or embody such goodwill and all renewals of the foregoing.
- 2. <u>Authorization to Record</u>. The Administrative Agent authorizes and requests that the United States Patent and Trademark Office and any applicable government officer record this Patent and Trademark Release.


