**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (SECOND LIEN)**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (SECOND LIEN) (this “Release”), dated as of December 28, 2020 (the “Effective Date”), is made by Deutsche Bank AG New York Branch, as collateral agent for the Secured Parties (the “Agent”), in favor of Hardware Resources, Inc., a Louisiana corporation (“Hardware Resources”), Top Knobs USA, Inc., a New Jersey corporation (“Top Knobs”), Dimora Brands, Inc., a Delaware corporation (“Dimora”), Watermark Designs, LLC, a New York limited liability company (“Watermark” and, together with Hardware Resources, Top Knobs, and Dimora, the “Grantors”).

WHEREAS, pursuant to that certain Second Lien Guarantee and Collateral Agreement, dated as of August 24, 2017, by and among the Agent, the Grantors and certain other parties thereto (as amended, supplemented, waived or otherwise modified from time to time, the “Security Agreement”), the Grantors granted to the Agent, for the benefit of the Secured Parties, a security interest in all of the Grantors’ Intellectual Property, including the Trademarks, Copyrights and Patents;

WHEREAS, pursuant to the Security Agreement, Top Knobs executed and delivered a Second Lien Intellectual Property Security Agreement, dated as of August 24, 2017 (the “2017 Top Knobs Security Agreement”), recorded with the United States Patent and Trademark Office on August 28, 2017 at Reel/Frame 043687/0719 and Reel/Frame 6139/0622;

WHEREAS, pursuant to the Security Agreement, Hardware Resources executed and delivered a Second Lien Intellectual Property Security Agreement, dated as of August 24, 2017 (the “2017 Hardware Resources Security Agreement”), recorded with the United States Patent and Trademark Office on August 28, 2017 at Reel/Frame 6139/0269 and Reel/Frame 043687/0111; and recorded with the United States Copyright Office on August 31, 2017 in Volume 9948, Document No. 834;

WHEREAS, pursuant to the Security Agreement, Top Knobs executed and delivered a Second Lien Intellectual Property Security Agreement, dated as of March 9, 2018 (the “2018 Top Knobs Security Agreement”), recorded with the United States Patent and Trademark Office on March 13, 2018 at Reel/Frame 6302/0980;

WHEREAS, pursuant to the Security Agreement, Hardware Resources executed and delivered a Second Lien Intellectual Property Security Agreement, dated as of March 9, 2018 (the “2018 Hardware Resources Security Agreement”), recorded with the United States Patent and Trademark Office on March 13, 2018 at Reel/Frame 045571/0192 and Reel/Frame 6303/0001.

WHEREAS, pursuant to the Security Agreement, Dimora executed and delivered a Second Lien Intellectual Property Security Agreement, dated as of March 9, 2018 (the “Dimora Security Agreement”), recorded with the United States Patent and Trademark Office on March 13, 2018 at Reel/Frame 6302/0987;

WHEREAS, pursuant to the Security Agreement, Watermark executed and delivered a Second Lien Intellectual Property Security Agreement, dated as of August 13, 2019 (the “Watermark Security Agreement” and together with the 2017 Top Knobs Security Agreement, the 2017 Hardware Resources Security Agreement, the 2018 Top Knobs Security Agreement, the 2018 Hardware Resources Security Agreement and the Dimora Security Agreement, the “IP Security Agreements”), sent for recordal with the United States Copyright Office on August 16, 2019, pending recordation;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, on behalf of the Secured Parties, hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement, or the IP Security Agreements, as applicable.

2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to all Intellectual Property Collateral, including (x) the trademark registrations and applications set forth on Schedule 1 attached hereto, arising under the Security Agreement and the IP Security Agreements, (y) the copyright registrations and applications set forth on Schedule 2 attached hereto, arising under the Security Agreement and the IP Security Agreements and (z) the patent registrations and applications set forth on Schedule 3 attached hereto, arising under the Security Agreement and the IP Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in the Intellectual Property under the Security Agreement and the IP Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to such Grantor.

3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels each of the IP Security Agreements.

4. Further Assurances. The Agent agrees to take all further actions, and provide to the each Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by such Grantor, at such Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Recordation. The Agent authorizes and requests that the Register of Copyrights, Commissioner of Patents and Trademarks and any other applicable government officer record this Release.


6. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.
